LINCOLN-It's a dull season when the state capital crowd hasn't something to talk about. Just now it's the penitentiary, Warden Olsen having been removed by action of the board of control on January 3.

The matter of auditing the records, some "inside" transac-tions and alleged "insolence" on the part of the deposed warden account for his removal.

4. Industry cooperation. Beer Industry Self-Regulation, as carried on by the Nebraska Committee for over 8 years, has been effective in assuring clean law-abiding conditions in Nebraska beer retailing establishments, and will continue to do so.
