AUTO REGISTRATION FEES
 While many people claim there is a shortage of money this year, the records in the office of County Treasurer Conklin disclose the fact that there has been more money paid into the office of the county treasurer, from January 1, 1932, to May 31, 1932, than there was in the same period last year, for auto license fees. EDUCATIONAL NOTES
Notice—All School Boards
 Session Laws, 1931, H. R. No. 141—Nebraska School Laws
 Be it Enacted by the people of the State of Nebraska:
 Section 1. That any school district treasurer or township treasurer may deposit the money received or held by him by virtue of his office in some state or national bank situated in such school district or township or in some nearby city or village which has been approved as such depository by the governing body of such school district or township.
 Section 2. Any such bank may apply for the privilege of keeping such moneys. All such deposits shall be subject to payment on check when

demanded by the district or township treasurer. It shall be the duty of the school district board or township board to act upon such application.
 Section 3. No such treasurer shall be liable on his bond for money on deposit in a bank under and by direction of the proper legal authority.
 Passed with emergency clause to become effective March 25, 1931.
