BRIEFLY STATED

Federal Agent Bay, assisted by a deputy state sheriff and a couple of other federal agents, made a few arrests in this city last Tuesday of persons who were charged with the sale of intoxicating liquor. Those arrested were: Mr. and Mrs. Oscar Dixon, Gene Morgan, Asa Hicks, of O'Neill and Charles Allman of Stuart. They were all taken to Ainsworth to appear before U. S. Commissioner Scattergood for the purpose of giving bond for their appearance at the next term of Federal court at Norfolk, next September. We understand that all of those arrested have been charged with the sale of liquor, as Federal agents claimed to have made buys of all those arrested on several occasions.

A smooth talker, representing an aerial act, visited the city the forepart of last week and prevailed upon some of our merchants to donate for an exhibition to be given last Saturday evening and to call Saturday "booster day." Some of the merchants fell for it and put up the money and the show was pulled off as advertised, on bills that were printed in another city and state, but the crowd from the country, that was promised, failed to materialize and we have serious doubts if any of the merchants who donated received any benefit directly or indirectly from the performance, or the \$125 donated. A "Booster Day" is a good thing for any town, but there must be something to entertain the people when they come to town, besides one aerial act lasting but a few minutes. Then again it takes time to properly advertise it so the people will know they are to be given an entertainment. Arrangements for a real "booster day" celebration cannot be made in a few days, it takes time.

In DISTRICT COURT.

Kate Hartigan, of Inman, has filed suit in the district court praying for a decree of divorce from Stuart Hartigan. In her petition she alleges that they were married at Neligh on April 6, 1912. That as a result of such union the following children were born: Marvel Hartigan, aged 19 years and Doris Lee Hartigan, aged 12 years. She further alleges that at the time of their marriage they had no property or money, but that as a result of their labor, effort, self denial and sacrifices have accumulated some property consisting of a house and one lot in Inman and some personal property, consisting of live stock. She alleges that the defendant has been guilty of extreme cruelty without and cause or provocation on her part. Has repeatedly told her that he did not wish to live with her any longer and told her to get out. That he has at times cursed and swore at her and called her vile names, without cause or provocation. She asks for an absolute divorce and the custody of the children and asks that he be required to pay support money until the children become of age and that he be required to pay such alimony as the court may deem reasonable as well as attorneys fees and costs of suit.

The Travelers Insurance Company vs. Winfield Wanser and Lula Wanser, et al. is another case filed in the district court this week. In this case the plaintiff seeks to foreclose a mortgage given by the defendants on April 28, 1924, on the following described premises to secure the payment of a loan of \$7,000.00: Northeast quarter of section one, township twenty-eight north of range ten, west of the 6th P. M. Plaintiff alleges that the note was due on May 1, 1929, and being unable to pay at that time secured an extension. That they paid on the prin-

cipal the amount of \$310.00 on May 12, 1930, and \$610.00 on May 2, 1931, but have made no further payments. That the defendants refused and neglected to pay the interest on the balance of the principal which came due on May 1, 1932, and likewise neglected and refused to pay the taxes due for 1931. They further allege that they have violated the provisions of the mortgage and plaintiff elects to declare the entire amount, \$6,150.45, due and payable and asks for a decree of foreclosure and sale of said property.

CITIZEN'S MILITARY TRAINING CAMPS

Washington, D. C., July 28.—Citizen's Military Training Camps enrollment this Summer reached the record figure of 98,606, bettering last year's total of 81,152, according to statistics made public today by Major General Charles H. Bridges, The Adjutant General of the Army.

Only 37,500—slightly more than one third of the qualified candidates—can be admitted to the camps under appropriations available for this fiscal year.

Leading in other sections of the United States the Fourth Corps Area, with headquarters at Atlanta, Ga., registered 15,441 applicants. Other regions producing high totals were: Seventh Corps Area, Omaha, 14,089; Third Corps Area, Baltimore, 12,428; Sixth Corps Area, Chicago, 12,304; Fifth Corps Area, Columbus, Ohio, 11,882, and Second Corps Area, New York, 11,307.

Fifty-one C. M. T. C. encampments are being conducted for thirty days throughout the United States this summer. Plattsburg Barracks, on Lako Champlain, N. Y., famous for its part in the inception of the civilian camp movement, is the largest of the group, training 2,122 youngsters.
