CONSTITUTION

OF THE
WEBSTER COUNTY AGRICULTURAL SOCIETY.

ARTICLE I.

This Society shall be known as the
WEBSTER COUNTY AGRICULTURAL SOCIETY.

ARTICLE II.

The object of this Society shall be the
promotion of Agriculture, Horticulture,
Stock-raising, and the Mechanical Arts.

ARTICLE III.

The officers of the Society shall be a
President, Vice President, Secretary,
Treasurer, and an Executive Committee
of six members, one to be elected from
each voting producer in the county,
all of whom shall be elected at the An-
nual Meeting of said Society, and shall
hold their offices one year, and until
their successors are elected.

ARTICLE IV.

The President shall preside at all the
meetings of the Society, sign all orders
on the Treasurer for money, give the
existing vote in case of tie, and perform
all other duties usually required of a
President.

ARTICLE V.

It shall be the duty of the Vice President
to assist the President in the per-
formance of his duties when required,
and to preside in his absence.

In the absence of both President and
Vice President, the Executive Committee
shall elect one of its members to preside
in the place of the President.

ARTICLE VI.

It shall be the duty of the Secretary
to record the proceedings of the Society,
to receive all monies and to pay the
same over to the Treasurer, to take his
receipt therefor, countersign all orders
on the Treasurer for money, and to give
notice of all meetings of the Society,
and to correspond for the benefit of the
Society.

ARTICLE VII.

It shall be the duty of the Treasurer
to receive all monies of the Society from
the Secretary, give him a receipt there-
fore, and pay the same out on the order
of the President counter-signed by the
Secretary, and account to the Society
for all money received by him. The
Treasurer before entering upon his
duties shall give a bond in such sum as may
be designated by the Executive Com-
mittee.

ARTICLE VIII.

The Executive Committee shall be
the Finance Committee of the Society.
It shall meet on the first Saturday in
May, of each year, and settle with the
Treasurer, and attend to all the financial
and other business of the Society.
