REPORT OF COMMITTEE APPOINTED TO INVESTIGATE COUNTY RECORDS.

Red Cloud, March 18, 1882.

Board met pursuant to adjournment. Present Leon May, Hugh Stevenson, J. D. Smith, commissioners; Joe P. Bayha, clerk.

The Board of County Commissioners, having concluded their work of examining the county records, James Thorne and William H. Struble employed as experts to assist in said examination, made the following report, which was presented and approved, and to said report is appended a report in conclusion of the Board of County Commissioners. Both reports are duly signed and attested by the county clerk, as follows, to wit:

To the Honorable Board of County Commissioners of Webster County, Nebraska:

GENTLEMAN.—Pursuant to our order authorizing us to make a thorough examination of the records, accounts and fee books of the county clerks, and county treasurer's offices, and report the result of the investigation at the earliest convenience—having performed that duty, we respectfully submit the following for examination and consideration:
