County Commissioners Proceedings. RED CLOUD, NEB., Oct. 6, 1884. Board of county commissioners met in regular session, J. E. Smith and J. L. Miller, county commissioners. J. P. Bayta, clerk.

Minutes of previous meeting read and approved, after several corrections made on record of Sept. 23, 1884. Petition for public road east of north end of Guide Rock bridge across the Republican river, filed Sept. 1, 1884, by D. McCallum and others for the road to remain where it was first laid off and now cleared off on said D. McCallum's land, was granted, provided said D. McCallum will execute and deliver to the county a dedication deed of said land occupied by said road. Said dedication was duly executed and delivered to the board and accepted by them and the road ordered established as per prayer of said petition.

Samuel Fox having declined to serve as O. H. R. D. No. 28, the board appointed Wm. H. Thomas O. H. R. D. No. 28, who filed his official bond which was duly approved. Claim of W. H. B. Stout referred to J. W. Warren, sheriff, to be accounted for in his bills of costs. Also claim of W. Dany referred to him for payment out of C. H. fund.
