Removal of Deeds.

The matter of the election of a recorder of deeds in counties of less than 10,000 population was up for consideration before the Republican State Central Committee, and as the committee was informed that Attorney General Lusk had advised all counties having over 1000 people to elect a recorder as the act of the last legislature as signed by the governor, applied to all counties of 1000 inhabitants and over, and must be obeyed as a law until it is declared unconstitutional, by the proper tribunal.
