CURRENT COMMENT.

The estate of the late Henry P. Kildner, of Boston, foots up to a valuation of \$2,189,624.

A number of ladies have been arrested at Lacombe, N. H., charged with stealing memorial offerings from the Union cemetery.

The statistics of German exports from January to April, inclusive, indicate a large increase in the exportation of textile fabrics, hardware and machinery.

The Providence (R. I.) Base Ball Club, at a meeting recently, decided to disband, owing to the poor attendance at the games. It opened the season with \$2,000 in the treasury, and was in debt about \$10,000.

Harrison, of Tennessee, introduced a bill in the Senate recently providing for the payment to Mrs. E. H. Brown, now nine hundred dollars for Government advertising in the Knoxville Daily, published by her husband, the famous "Parson" Brownlow.

While Deputy United States Marshal Green and posse were approaching the illicit distillery of Hight & Barnes, in Benton County, Tenn., recently they were fired upon by moonshiners. The shots were returned and a lively fusillade was kept up several minutes, but no one was hurt. The revenue men were compelled to retreat.

The remains of an immense monster, have been found by some ditchers in a marsh, located eight miles south of Elkhart, Ind. One piece of shoulder blade weighed over forty pounds and a tooth, well preserved, weighed four pounds and a half. The frontal bone measured three feet in width, and a piece of the trunk five inches in diameter.

The following curious dispatch comes from Munich: The Bavarians, having quite made up their minds to get rid of King Louis, are now anxious to discuss ways and means. Means while the King has withdrawn from the vulgar gaze and barred out his ministers, who have lately been permitted to communicate with His Majesty through the royal hair-dresser.

At a recent meeting of the Chicago Council Mayor Harrison vetoed the ordinance passed immediately after the Haymarket massacre providing for the addition of fifty men to the police force. The Mayor held that there were no funds available for the payment of the new men. He also declared that recent events had shown there was no necessity for the appointment of additional police.

So far as examined the books of the suspended Merchant's National Bank, of Peoria, Ill., show that J. Finley Hoke, late book-keeper, and now sojourning in Canada, has succeeded in stealing \$180,000 of the bank's money, and it is believed when the examination is concluded it will be found to be \$200,000. The bank officials say that Hoke had simply stolen money from the counter and drawers and lived his books accordingly.

A very curious claim has been received at the Treasury Department in the shape of a certificate of indebtedness of the Government to John Vester, of Philadelphia, dated February 11, 1783, signed by Joseph Nourse, registered and bearing interest at 6 per cent. from December 20, 1783. Although the certificate is for only \$1,000, the interest due on it amounts to \$11,025, making the amount of the claim \$12,775. First Controller Durbin is looking into the matter to see if the claim is valid, so it may be paid to Vester's heirs.

About one thousand circulars announcing the President's marriage were sent out from the White House by mail, messenger and otherwise. They are exceedingly simple, plainly engraved in heavy lines on a full sheet of fine note paper. They read as follows: "Mr. Grover Cleveland and Miss Frances Folsom, married, on Wednesday, June 2, 1886. Executive Mansion, Washington." These announcements were sent to members of the Cabinet, Justices of the Supreme Court, Senators, Representatives in Congress, the Diplomatic Corps, Lieutenant General of the army, Admirals of the navy and other officials in Washington, and to personal friends of the President and Mrs. Cleveland in Albany and Buffalo.

The order of Secretary Lamar suspending entries under the pre-emption and timber culture laws was made, it is reported, after consultation with members of the Committee on Public Lands in both houses of Congress. Bills are now pending in both houses to repeal the pre-emption and timber culture acts. There is an almost unanimous sentiment in both houses of Congress in favor of their repeal, and it is only a question of opportunity. Secretary Lamar having learned that a great many pre-emption and timber culture entries were being made in order to anticipate the repeal of the laws he decided to suspend them until the end of the session, when, if the laws are not repealed, the suspension will be regarded.

CONGRESSIONAL.

In the Senate on June 1 Mr. Beck introduced a bill to prohibit members of Congress from acting as attorneys or employees of railroad companies that had chartered or acquired rights from the United States. The bill forbids the right to act as attorney or employee of the Northern Pacific Land for future bills. At the same time the bill was taken up, several other bills were taken up, but no final action was reached on any. The Supplementary Chinese bill was taken up in the House, the Commerce bill was taken up and further debated in committee of the Whole. Adjourned without discussion.

In the Senate on the 2d after routine business, Senator Brown spoke against the Bankruptcy bill. The Northern Pacific for the bill was taken up and discussed until ten o'clock, when the National Land Taxation bill was before the Senate and discussed until ten o'clock. Adjourned.

In the House several bills were introduced to the Post-office Appropriation bill. Mr. O'Neil reported a bill to legalize the incorporation of the Post-office. The Commerce bill was then further considered in committee, at the expiration of which the committee reported the bill to the House. Adjourned.

In the Senate on the 3d Mr. Dwyer presented a petition from the city of New York, praying for the repeal of the act of March 2, 1877, which authorized the city of New York to issue bonds to the amount of \$1,000,000 for the purpose of paying the interest on the city's debt.
