He devised and executed the despicable plot by which the New York legislature was made democratic when the people had voted that it should be republican; and he is dictating all that is done by that body. #### A MARKED CONTRAST.

In the Democratic racty All Is Confusion and Uncertainty.

There has seldom been a time in the history of existing parties when the situation seemed more assured in regard to the choice of a republican presas to the selection of his democratic opponent. Four years ago the democrats took the initiative at St. Louis on the 5th of June, and the republicans rallied two weeks later at the old stand, Chicago, on June 19. This year the administration party leads the way at Minneapolis on June 7, and the democrats, after two weeks interval, convene at Chicago on June 21. In 1888 the democratic convention nominated President Cleveland for re-election. and in 1892 the republican convention will again present the name of President Harrison. The effect of Mr. Blaine's withdrawal fully justifies this prediction, strengthened as it is by Secretary Blaine's declaration that President Harrison is the logical candidate of his party and deserves a renomination. Complimentary votes, thrown by different states in recognition of "favorite sons," will not mislead the sentiment of the convention when it converges upon the final ballot. The democratic situation is bewildering. Mr. Cleveland's strength is large-

ly dependent upon a weakness of his party. He is great among democrats because he is the acknowledged first among a few availables established in the popular confidence. In 1884 the presidency was a candidate for Mr. Cleveland, but the fruits of his victory were sacrificed in an attempt to adjust "honest polities" to the demand of undemocracy. Since then the worst enemies of Mr. Cleveland have been found in the ranks of his own party. The opposition to his nomination is no longer confined to New York. The radical silver men of the party, who regard the free and unlimited coinage of silver as being of greater importance than the question of tariff reform, are unfriendly to Mr. Cleveland. Mr. Gorman. Mr. Breckinridge, Mr. Blackburn, Mr. Bland, Mr. Crisp and other distinguished southern leaders are looking for another candidate. Assurances have been given that southern states which sent solid delegations for Cleveland in 1888, are pledged to send solid delegations to oppose him in 1892. The west still remains steadfest to the ex-president, but the outcrop of western eandidates, which includes Palmer and Stevenson and Chief Justice Fuller, of Illinois; Gray, of Indiana; Boies, of lowa, and other promising aspirants, is somewhat depressing to the supporters of the "ideal candidate."

The New York democratic despotism has found a most fitting champion in David B. Hill, whose desperate political methods have culminated in the theft of the legislature of the empire state convention which has throttled the expression of Cleveland sentiment in the party and will send a solid Hill delegation to Chicago. All the shouting for Grover Cleveland outside the walls of the Auditorium will count for nothing against the unit vote of Now York for Hill in the convention. Only the timely and spontaneous awakening of the moral sense of the party can rescue the Chicago convention from the clutches of a machine usurpation which would inevitably destroy the party.

The battleground of the coming contest will be President Harrison's state of Indiana. The orratic action of Iowa and Massachusetts in electing demoeratic governors last year need not ambarrasa political calculations as to the attitude of these states on national questions. Presumably the republican states which voted for Harrison in 1888 will, with the possible exception of New York and Indiana, vote for the republican ticket in 1892, and the states which voted for Cleveland in 1988 will vote for the democratic candidates in 1892. In such case the republicans could afford to lose New York if they carried indiana, for that would give them 225 electoral votes, two more than is necessary to a choice, assuming that the vote of Michigan will be divided. Hence it would not avail the democrats to carry New York, and Montana, too, if, on the other hand, they cannot parry Indiana. That Mr. Harrison can carry Indiana has been demonstrated, and, all other things being equal, in the absence of any exciting new controversy, the republicans may take heart of hope in presenting him as the most available presidential candidate for the campaign of 1892 -Chicago Graphie.
