Miller, late cand's date on the independent ticket for clerk of Webster count filed his petition in the county court, asking for a recount of the ballots cast on November 7, 1893, alleging much crooked ness on the part of the judges of election in Red Cloud and Line township, as well as in the first ward of the city. Mr. Miller charges mal-conduct and other serious intentions on the part of the judges to defeat him. He again claims that a great many electors voted for him, and that their votes were counted for others. This would indeed be a serious matter were the charges backed up with sufficient evi- shed for his stock. dence to warrant the statement, but THE CHIEF does not apprehend that the charges can be proven, and does not believe that the sworn judges would falsify the returns over so small a matter, where the interests are of so little importance to the community. Had the election centered on some great issue, the case might have been different, still this paper will refrain from any remarks that might be prejudicial to the contestants until the case is decided. Below we give the petition in full as filed in Judge Duffy's court. Jacob L. Miller contestant, )

L. H. Fort incumbent, In county court of Webster county, Ne-Jacob L. Miller contestant complains of L. H. Fort incumbent that on the seventh day of November 1893, an elec-tion for county and state officers was duly held in the several townships and duly held in the several townships and voting precincts in Webster county, Nebraska, at which election contestant and incumbent were duly elected candidates by their respective political parties for the office of county clerk of said Webster county, Nebraska, and had their names duly placed on the official ballot voted at said election for said office. Contestant then and there being an elector in said said election for said office. Contestant then and there being an elector in said county and state and competent to contest such election, and being in all respects a legally qualified candidate for office. On the 9th day of November 1893, the results of said election were duly canvassed, and it appeared therefrom that the contestant has received, 883 votes and the incumbent, 902 votes, and D. J. Meyers, received 406, and inand D. J. Meyers, received 406, and in-cumbent L. H. Fort was declared by said canvasers of said election, elected to said office of county clerk. That said election, did not result in the election of said incumbent, but did result in the election of contestant, who received more votes for said office of county clerk than did incumbent. That there was mal-conduct on the part of the judges of election in Red Cloud township sufficient to change the result of said election. That eightsen defaced ballots were counted at said election which ballots were purposely defaced and marked by the electors voting them, for the purpose of identifying the ballots so voted by them from the other ballots; which ballots were counted against this contes-tant and in favor of incumbent. That the letter and spirit of the law, were so violated as to prevent a free, fair and unhindered expression of the voters at said election of their purposes. That official tickets were given out, to the electors, who were then permitted to be approached by partisans at the polling places which tickets were marked by said partisans other than the electors. said partisans other than the electors judges of election, and were voted and counted, after being so marked. That parties other than the judges, were permitted to and did approach and solicit the votes, after the official tickets were handed to them by the judges, and before said tickets were marked and voted, and then said tickets were received into the ballot box, and counted in the result. That in the counting of said ballots.

the judges of the election were over ruled by the clerks and bystanders two of the judges voting for the rejection of the bal lots as the counting of others, and the other judge and the two clerks encour aged by the bystanders over ruling them. And counting or rejecting the ballots against the will and vote of two judges of election—that more tickets appeared in the ballot box, and were counted and returned, than there were voters at said e ection. That candidates were permit-ted to handle and deface, and did handle the tickets voted at said election, while the count was in progress.

That in the counting of said ballots

violations of law the accurate vote of said townships, cannot now be obtained. And the whole township should not be counted in this election. The returns of said townships gave incumbent a plurali ty of 21 votes over contestant in said township when in truth and a fair election he would not have received any plurality, whatever. That there was er ror and mal-conduct on the part of the judges of election of the first ward of Red Cloud city in said county in counting the votes thereof, whereby of fifty votes cast for this contestant, only twenty-two were counted and returned as cast for him, and the rest or twenty-eight were count-ed for incumbent or D. J. Meyrs. That there was error and mal-conduct in the part of the judges of election in Line township in said county, in counting and returning the vote whereby of seventeen votes cast for contestant, only eight votes were counted and returned as cast for him, and the rest were counted and returned as cast for incumbent, and said D. J. Meyrs; wherefore contestant asks that the vote of Red Cloud township, be set aside, that there be a recount of the ballots in the first ward of Red Cloud township and in Line township, and that the votes so failed to be counted and returned for contestant, be now counted and the contestant be declared elected to the office of county clerk, and for suh other judgment as may be right in the premises.
