EDUCATIONAL NEWS

HAPPENINGS IN OUR SCHOOLS

Furnished by County Superintendent D. M. Hunter, -- A Communication from the University of Nebraska.

(Continued from last week.) A COMMENT.

I will also state that of the entire number attending the county high school of Dickinson county, more than 90 percent are boys and girls from the farm. In fact, it is a farmers' institution; but equally as useful to the city, for the county high school affords many advantages which in my estimation the city high school does not such a school is not great to the county. Only one mill tax has been eration of the law. levied annually for the support of the Dickinson county high school. I will add further, that the county high school of Dickinson county is well patronized by the people of every portion of the county. Parents go to the Chapman, where the school is located; rent rooms for their children and provide them with the necessary furniture (often taken from home), and also provide them with the necessary food.

I sincerely believe that if the people of our county could be led to see the benefits to be derived from the establishment of a county high school, that the vote would be unanimous."

CONCLUSION. In conclusion the University authorties ask that the press of the state give the widest publicity the changes herein proposed, and suggest that the county high school be made a matter of thoughtful consideration and earnest discussion on the part of all citizens. If the next legislature is convinced that this legislation is generally and intelligently demanded by the people of the state, there will be no difficulty whatever in passing this law; thus putting Nebraska far in the lead in the completion of that which will be a state system of public education worthy of the name.
