Last week the article on "The Teacher as a Character builder," in this column should have had Miss Mary Farquhar's name attached to it.

The time is drawing near for our annual county teachers' institute. Only a very small number of teachers have asked to be excused from attending the institute this year, compared with the number that have wished to be excused other years. The few that have been excused will be engaged in receiving professional training at other places; nearly all will attend a term at a normal school during the summer.

No teacher should think of being excused from institute unless it is absolutely impossible for him to attend, or unless he attends a summer normal for professional improvement. In employing a teacher, school boards would be justified in paying a teacher less wages per month on account of his not attending institute, than they should pay him if he had attended institute.

An experienced teacher owes to the profession his presence at institutes not only to keep himself in sympathy with educational advancement, but also to encourage the younger teachers and to aid them in fitting themselves for their work in the schools.

It costs something to prepare for teaching, and year after year, to improve professionally. Those who do not wish to pay the cost of preparation and improvement for teaching should do some other kind of work, as the boys and girls in our schools can not afford to be taught by half hearted, non-professional working-for-only-the-pay-that's-in-it teachers. The educational sentiment, improvement in our schools, has been steadily growing year after year among the people of Webster county and there are many districts that pay well those teachers who they know have done or will do good work.

The small number that have asked to be excused (manufacturing only a frail excuse) shows a healthy professional spirit among the great majority of our teachers.

The superintendent strongly urges attendance at institute, and will positively refuse to excuse persons from attending except on account of sickness, attendance at some other professional training school, or for some other exceedingly good reason.

A young teacher with enthusiasm and a desire to improve is preferable to one with experience and lack of interest in institutes, teachers' meetings and other means of improvement.

Many teachers have done their best work in the schools during the first year of their teaching.

The annual school district meeting will be held in all school districts next Monday June 25th. Every patron should be present at the annual school meeting, and have a voice in doing something to advance the educational interests of his district.
