### MADRID IS EXCITED!

RUMOR THAT UNCLE 'SAM HAS WARNED SPAIN.

Ppanish Minister Said to Have Notified His Government That This Country Would Act Unless the Cuban Rebellion to Soon Suppressed-State Dept. Mum.

WASHINGTON, Oct. 12 .- A cable mesmge from Madrid received here early this morning said that it was reported there on the best of authority that the American government had notified the Spanish minkter at Washington that it was necessary for Spain to act promptly in crushing the Caban in-surrection, and that the report caused a profound sensation in Madrid.

The truth of the report cannot be confirmed at the state department. The officials, when approached, would neither affirm nor deny the story. though their manner would indicate disapproval of its accuracy. It is be-lieved quite probable that representations may have been made to Spain of the wisdom of aggressive and active operations against the Cuban insurgents, but it is thought that the United States government did not make these suggestions, and that, if made, they came from Minister DeLome and were based on his personal views of the situation and on his observation of the trend of sentiment in the United States and his knowledge of the purpose of the friends of the insurgents to press their cause vigorously soon after the assembling of congress.

Daily events point strongly to a de-termination to force the question on the attention of congress in the belief that the legislative channel affords the most practicable route to the accomplishment of something in behalf of Caban independence, the executive branch of the government, in the very nature of things, being more con-strained in its action than the legisla-

tive department. Senor DeLome left here to-day on a very early train, and therefore no in-formation could be gained from him concerning the Madrid dispatch.

THE POLICY OF THIS COUNTRY. Senor DeLome, the Spanish m'nister, had a short interview with Secretary Olney yesterday, and in the course of their conversation the minister, perhaps in answer to the secretary's inquiry, made a statement that operations in Cuba would be conducted with greater vigor hereafter. As the president must certainly make some reference to the insurrection in his annual message to congress when it meets in December, it would be but natural that Secretary Olney, upon whom he must rely for his informa-tion, should take steps to gather data upon which to base a judgment of probable future events.

While it is true that President Grant did, as indicated in his messages to congress, entertain a belief that intervention in the then progressing rebel-lion in Cubs would be justifiable, this view was never acceptable to Secre-tary Fish, and it has not secured the adherence of international lawyers. The whole weight of authority is de-cidedly adverse to the assertion by a neutral nation of a right to say when war between two combatants has progressed to a point where it must be stopped. It may be recalled t some such proposition was deduring the last stages of the China-Japanese war, but it never went further than the exercise of the good offices of the interested nations to bring about peace, which function is estirely distinct from direct intervention. The question is also separate from that of the recognition of the belligerence of the insurgents, which, according to American policy and ractice, must be determined purely by the facts in each case.

# FORTUNE IN A ROOM.

Over a Million Dollars Left Behind By a Woman Reciuse.

CAMBRIDGE, Mass., Oct. 12.-Mrs. Sarah Coolidge, for thirty years a recluse in a secluded house here, died of apoplexy Wednesday. She always passed as a woman of moderate circumstances. When the undertaker disrobed the body preparatory to embalming it, he found various assortments of gold coins tucked away in concealed pockets in her clothing.

This led to a search of the room and

it proved to be a veritable gold mine. In vases and in other pieces of brie-a brac, in shoes, in bureau drawers, and in every conceivable nook and crapny the searchers found \$20,000 in cash mostly in gold coin. In one dilapi-dated handbag was a roll of bills ag-gregating \$3,800. On the shelf in her closet were bank books representing scores of thousands more, with securi-ties and deads above. ties and deeds showing a valuation of over a million dollars. One document showed her to be the owner of prop-erty at the corner of Washington and Avon streets, Boston, which pays a rental of \$1,000 a month.

In addition to the money and the bank books there were dresses of the most stylish and expensive goods, covered with jewels and old laces. Many of these gowns would easily receive a valuation of \$1,000 cach. the chamber closets and wardrobe were filled with these expensive gowns and none of them have ever been

The servants were never permitted to enter the room in which the treasure was found, though there was no special effort to secure protection from thieves. There were over \$300. 000 of negotiable securities in that room gnarded only by an old wo man room guarded only by an old wo man and four women servants. Nobody dreamed that it was there, so the vast sum was secure.

"I have never for one moment regretted going upon the stage; neither have I ever cast one longing look back at the old society days, nor even thought with pleasure of the so-called social triumph I was said to have made. I look upon those things as hollow and utterly vapid; they mean absolutely nothing. It is nine years since I left New York, and I have lost all interest in the city's social set. Indeed, I care as little for them as they care for me. First of all, let me say that I was much amused "I have never for one moment reall, let me say that I was much amused at something said in the papers a few days ago about Mr. James Brown Potter's posing as a saint, keeping his home ready for my return at any time I chose to come back. It is very nice of Mr. Potter to express such sickly sentiment. That house and home happens to be mine, as well as everything in the house. It was given to me by Pierre Lorillard for the successful work I did in getting people to join the Tuxedo club.

"My ideas of life and those of the Potters were at variance. I was brought up to think that life was real and that love ruled the world. The Potters lived only for outside show, always seemed to be afraid to appear natural and were always at swords' points with one another. There was nothing natural, nothing genuine in this new life I was leading. All was conventional, all surface. My enthusithe Potters. My success in private theatricals paved the way to something better, and one day, sick and weary of all the mockery, tired of the constant fault-finding to which I was compelled to submit, tired of going out with a smilling face and a breaking heart, tired of the snabs of the Potters, who are always jealous of each m and naturalness were chilled by ters, who are always jealous of each other, tired of genteel poverty, I walked out of that home Mr. Potter is keeping for me and left everything be-hind me. I have never been permitted to go back to get my belongings, and not even as much as a pair of sleeve buttons has ever been sent me. I sacrificed little to gain the glorious her-itage of honest independence."

### OFFICIALS DENOUNCED.

Hot Shot for Admiral Kirkland and Min-

ister Terrell. OSHKOSH, Wis., Oct. 12 .- Admiral Kirkland, in command of the United States naval forces in the Mediterranean, and United States Minister Terrell were roundly denounced in the Presbyterian synod meeting yesterday by two ministers who had lately returned from an extensive visit in the far East. The statements were boldly made that Admiral Kirkland was a disgrace to the navy and that Minister Terrell was partial to the Mohammedana.

The report lately sent to this country by Rear Admiral Kirkland of the American pavy, that the missionaries in Asia Minor had unduly excited the people and were in a great measure the cause of recent troubles, was strongly denounced by the Rev. Mr. Cady, and he recited several instances that came under his personal observation last winter going to show that in his opinion Rear Admiral Kirkland was morally incompetent to pronounce judgment upon questions pertaining to missions, and a more profane and demoralized man than Admiral Kirkland the Rev. Mr. Cady did not meet with in his travels.

The Rev. W. O. Carrier spoke to the same effect and said Judge Terrell, the American minister to Turkey, made his investigation of the recent troubles a mere farce. The judge dined with the sultan once a month and openly avowed his partiality to Moham-medanism and sees no reason why missionaries should be sent to the Ottoman empire.

Both the ministers claimed that, with a few exceptions, American representatives on the Mediterranean coast were morally unqualified to represent American sentiment.

# DEBS CONTRADICTED.

The Illinois Federation of Labor Not Against Railway Brotherhoods.

PRORIA. Ill., Oct. 12 .- At the meeting of the Illinois Federation of Labor this morning the resolutions committee reported adversely a resolution declaring the convention is in entire sympathy with the action of E. V. Debs in his work of the strike of the American Railway union against Pullman and the Railroad Managers' association, but issuing a protest against any expression by him declaring that trades unloss were inadequate.

This elicited a stormy debate, lasting two hours, and finally the following was adopted as a substitute: Whereus, Eugene V. Debs has stated that the railway brotherhoods had been repudiated by organized labor,

Resolved, That the Illinois Federation of Labor deny such assertion, and extend to the railway brotherhoods our approval and assurance of continned esteem.

Resolutions were adopted boyeotting the Washburn-Crosby Milling company of Minneapolis and the Werner Printing company of Akron, Obio, and unanimously and heartily indorsing Governor Altgeld and his administra-

### ONLY A BASELESS RUMOR. Needless Alarm Over a Grave Report

NEW YORK, Oct. 12 .- A report obtained wide circulation through the country early this morning that Presdent Cleveland had been assassinated at Gray Gables, near Buzzard's Bay. Until after daylight this morning it

was impossible to obtain any positive denial of the report, the telephone and telegraph offices at Buzzard's Bay being closed. Then, however, it was learned that there was absolutely no truth in the rumor. On the contrary, the president and Private Secretary Thurber both started in the best of health at an early hour for the fishing grounds for a final fish of the season. The president will leave Gray Ga-bies to-morrow for Washington, but Mrs. Cleveland and the children will probably remain a few days longer.

Charges Against the Mutual Reserve Fund Life Association.

CHICAGO, Oct. 12.-Charges of a serlous nature are made against the officers of the Mutual Reserve Fund Life association of New York in a bill filed in the circuit court yesterday afternoon. The bill was prepared by Attorney W. L. Mason, who represented a number of the Chicago policy holders in the corporation, and is brought for the purpose of enjoining the company from declaring their policies lapsed, owing to a dispute which has arisen and which the courte are called upon to settle.

The complainants call the attention of the court to the different agreements by which the defendant company agreed that that the assessments should not be increased for the purpose of increasing the reserve fund, and they charge that in violation of these agreements with its policy holders the company has caused assess ments to be rated at an increase of 50 per cent.

The policies provide, according to the complainants showing, that the board of directors of the association may make an assessment when the death fund is insufficient to meet existing claims, and it further provides this assessment must be made upon any member whose certificate is in force at the date of the last death assessed for. In violation of this, the charge is made that the company has given a privilege to a class of policy holders who are younger, and whose policies are of later date than those of the complainants, thereby working great hardships upon the latter.

### COLORED CONFERENCE.

A Call Issued for a Great National Gathering Next December at Detroit.

CHICAGO, Oct. 12 .- A call has been issued by a committee of prominent negroes and from many states in the Union for a national conference of colored men, to meet at Detroit, Mich., on the 12th of December, 1895. The call, which is a lengthy one, says in part:

"We had hoped that after the na tional convention of colored men in Washington in 1873, we would have no further necessity for colored conventions, that the legislation before congress would work out the complete citizenship of the negro and place him in possession of the means to protect himself in the exercise of his rights. But here we are to-day, thirty years from the event of emancipation, and millions of free men are practically disfranchised: the constitution of the United States set at defiance; colored American citizens not allowed freedom of locomotion; the freedom of decent transportation, municipal corporations granting li-cense to private citizens to deny us ac-commodation in hotels, restaurants, barber shops, places of amusement,

The existence of mob and lynch law in disposing of colored men and women arrested on suspicion of committing gross offenses.

# DURRANT'S GREAT NERVE.

Goes Back On Him Just Once During Cross-Examination.

SAN FRANCISCO, Oct. 12 .- Under the rigid cross-examination of District Attorney Barnes, Theodore Durrant made a number of answers that are regarded as decidedly incriminating, inasmuch as they appear to be in direct conflict with well established facts.

He gave an explanation of a clue regarding Blanche Lamont's disappearance, said to have been received by him, that was so palpably a false-hood that everybody in the room laughed aloud. The stifling atmosphere of the overcrowded court room came to Durrant's rescue and he was enabled to recover from his confusion during the short recess that followed. When he again came to the stand he remained calm during the most trying ordeals. The prosecution was, nevertheless, well satisfied with the day's work, for it had accomplished wha had never been done before-Durrant for a moment had lost his wonderful self-possession, and had been caught in a number of barefaced untruths.

# GOVERNOR CLARKE.

The Arkansas Executive Expresses Him

self Veiledly as to the Prize Fight. LITTLE ROCK, Ark., Oct. 12 .- All that Governor Clarke will say to-day is that he shall see the law on the statute books as to prize fighting enforced to the letter. He has not yet determined what course he will pursue to prevent the fight, but it is the impression here that an extra session of the legislature will be called to take action.

Governor Clarke says that it would be a scandal on the good name of the state to have the fight in Arkansas. Nowever much the people of Hot Springs may want it, it is the interest of the whole state that he, as governor, is bound to conserve.

A large number of people in this city incline strongly to the opinion that the fight will take place at the Springs in spite of all opposition. The governor is expected to take action by to-morrow, and that action will be decisive.

# MRS. JAMES BROWN POTTER | INSURANCE MEN AT OUTS. | THE GOVEROR SAYS NO

THEY CAN NOT FIGHT AT HOT SPRINGS.

The Fighters and Their Managers Notified That Any Attempt to Pull off the Mill In Arkansas is Just So Much Time

LITTLE ROCK, Ark., Oct. 11,-Gov. ernor Clark, who has been examining the law closely touching the gubernatorial power to prevent prize fighting, has outlined his intentions in communications addressed to officers at Hot Springs and the principals of the proposed fight. The governor will hold himself ready to co-operate with Judge" Duffie, of the Hot Springs district, to prevent the fight, should it appear that the local authorities fail to im-press upon the fighters and their backers with sufficient force the propriety of declaring the fight off. In his letter to Judge Duffie, Governor Clark says:

"I beg to assure you that yoh shall have my prompt and cheerful co-operation in any effort you may make to suppress the proposed prize fight at Springs. Any order that you may make in this connection shall not prove ineffective for want of power to enforce it. I say this with confidence, because I hold in the highest respect the fidelity and courage of Sheriff Houpt. I feel sure that his active assistance can be relied upon, but it is said that even Jupiter sometimes nods. If it shall, contrary to my expectations, become necessary to proceed without the valuable aid of the sheriff, I stand ready to supply all

that may be necessary.

In addition to notifying President Stuart of the Florida Athletic club by mail of his determination to prevent the fight, Governor Clark telegraphed to Corbett and Fitzsimmons as follows:

"I am advised by the press dispatches that it is your purpose at an early day to engage in a prize fight in this state. The purpose of this is to inform you that such an act is a violation of our law and tion of our law and an affront to the sentiment of state pride entertained

"It will, therefore, not be possible, for you to accomplish any such purpose, and any attempt upon your part to do so will subject you to penalties and to treatment that I am sure will be highly distasteful to you. In the present state of public opinion, which at least is the force that influences penalties, prize fighters have no rights which those in authority are bound to respect. But there is no lack of law to make it now my duty to do all that is here indicated. As this is the only communication that I shall address to you, I have been somewhat more emphatic than would be the case if the matter were open to discussion.

### PARKHURST'S POSITION.

Although Sadly Disappointed He Will Support the Fusion Ticket.

NEW YORK, Oct. 14 .- Rev. Dr. Parkhurst yesterday broke the silence which he has maintained on politics since the fusion ticket was formed and stated his views on the situation. In his statement Dr. Parkhurst said:

"With the outcome of the efforts that have been made at fusion I am sadly disappointed. We are not satisfied to be told of a candidate that there is nothing in particular that can be said against him. Negation and colorlessness does not level up to the

grade of popular demand Whatever there may be in the situation that is faulty or deplorable we are not thereby absolved from the obligation resting upon us as citizens to gather ourselves up from any perplexity into which we may have been thrown from the unexpected to remember that altered contingencles have not modified the essential elements in the case, and that whatever other enemies there may be that will be required to be knocked down when their turn comes, it is neither robust citizenship or good strategy to concentrate this year upon any other enemy than the one we all combined to paralyze last year--Tammany hall. teresting as it would be to get all the birds of prey onto one branch and aim at general effects, yet blunderbus fighting is a mode of musketry that is neither the most economical nor the most effective. One enemy killed is better than haif a dozen enemies scorched. # TROUBLE IN COREA.

Two United States Warships at Chemulpo-The Queen Probably Slain.

WASHINGTON, Oct. 14.-Admirat Carpenter, in command of the Asiatic squadron, cabled to the navy department to-day that he had dispatched the gunboat Petrel from Che Foo to Chemnipo, the seaport nearest to Seoul, the capital of Corea. The Yorktown had already gone to Chemulpo, so that the United States will have two ships near the seene of the reported conflict.

A cable cipher from the admiral said that affairs in Seoul were in a very disturbed state and that officers of what is known as the "King's party" had taken refuge in the United States legation building. It was reported, the admiral went on, that the queen of Corea had been assassinated. At the urgent demand of the United States charge d'affaires at Seoul the marine guard of the cruiser Yorktown was sent to Seoul for the protection of the legation and American interests

WASHINGTON, Oct. 14.—Commodore Thomas O, Selfridge, president of the naval inspection board, has been ordered to report at the navy department to-day for examination for promotion to the grade of rear admiral in anticipation of the retirement of Rear Admiral C. C. Carpenter, next Febru-

The prospective promotion of Com-modore Selfridge will result in a state of affairs unprecedented in the history of the United States navy. It will ahow father and son in the highest possible grade of naval command. In this case, however, the father is on the retired list.

# TORCH AND DYNAMITE.

Cuban Insurgents Destroying Plantation and Wrecking Bridges.

KEY WEST, Pla. Oct. 14 .- Anarchy practically prevails on the island of Cuba according to letters received here. The Spanish are powerless, and outside of large cities, like Havana there is not even a pretense of government. Bands of insurgents roam at will, destroying sugar plantations and dynamiting railroad bridges. It seems to be the determination of the insurto be the determination of the insur-gents to destroy everything that would aid Spain in sustaining her army. In carrying out this policy the torch is being applied to the sugar plantations. In Santa Clara province, alone six of the largest plantations have been burned. The torch has also been ap-plied to the tobacco fields in certain districts. districts.

If the insurgents continue this policy, it will be but a short time until tnere will be nothing left in Cuba on which to sustain an army. The mail service is completely demoralized. The fasurgents have waylaid and taken many mail carriers, hoping to capture important dispatches. The carriers have become terrorized, and scores have resigned. Recently two Spanish mail carriers were captured by insurgents under Maceo and hanged. So great is the fear of the carriers that none will venture forth unless accompanied by armed guards. Whenever a carrier star's with an important dispatch he is escorted by a company of soldiers.

From the penal colonies in Southern Spain a battation of criminals has been organized and placed under the command of Colonel Garrido, who butchered the sick insurgents a few weeks ago. This battalion is known as the "squadron of death," because it has earned the title by killing women and children as well as the inmates of hospitals. Garrido, with his force will enter a village and place the women and children in front of them as a breastwork; then, when the Cubans come, they will dare them to fire, but will themselves shoot over the wemen's heads.

### ELOPERS FAIL

Sedalis and St. Joseph Couples Forced to Return Home Unmarried.

Quincy, Itl., Oct. 14.-Leonord Menefe, aged 18, and Lulu Yuchs, aged 16. left their homes at Sedalia, Mo., Thursday and came here to be married. They were taken in charge by the police on their arrival here and were sent back home last night. They eloped once before, going to Kansas. They met the same fate that they have encountered here. Both express their intention of trying it again, and hope that the third effort will prove a charm.

St. Joseph, Mo., Oct. 11.-J. Will Gray and Miss Mary Frances Judson returned from St. Louis yesterday unmarried. The girl is a daughter of W. R. Judson of the Turner-Frazer Mercantile company and the would-be groom is a salesman in a shoe house. Tuesday the young lady went to Atchison, ostensibly to visit friends, but instead was met at that place by Gray and the two left for St. Loui. soon as they arrived there they applied for a license, but were refused b Miss Judson is under 18. After ex-hausting all efforts they gave it up and returned here, where tiray made another effort to secure a license, but failed again. By this time the parents of the girl captured her. The result is yet in doubt.

### CHANDLER ON SILVER The New Hampshire Senator Makes Se

Bimetallic Promises.

DENVER, Col., Oct. 11.-In a letter

to T. C. Clayton, secretary of the Reing Republicans of this state to stand firmly with the national organization. Senator Chandler of New Hampshire says: "The Republican party will ge into the presidential battle pledged to bimetallism which I believe, as sure as right is right, will wip. On the other hand the Democratic leaders the men who dominate and control its national influence, patronage and organization—are gold monometallists. President Cleveland and his administration are absolutely in the hands of Mr. Pierpont Morgan and his syndicate of foreign bankers; they are against silver as a money metal and they are committed to gold mono-metallism. Brice the Democracy are hopelessly subjugated; and their next national convention will be as hostile to the convention will be as nostile to the principles of bimetallism as are the English creditors who propose to exact the pound of flesh from their debtors in all parts of the world. It is the height of folly for any bimetallist to conceive that anything but gold monometallism can come from another Democratic national victory. We bi-metallists outnumber the gold mono-metallists of the world 100 to 1, and need not fear that we will not eventually succeed. With a practical suggestion I close. A bimetallic convention held in the United States will be attended by representatives from all Western hemisphere governments and from the governments of Russia, France, Japan and China. Bimetallic organizations in Canada, India and every other country will send delegates. The decision of the conference that the nations should coin silver without limit at the ratio of 151, to 1 will be irresistible, even by England and Germany. ### CARROLLTON INCENSED.

A Brutal Assault on a Young Woman May End in a Lynching.
