## TROOPS ABANDON ALL FEAR

Capture of San Fabian a Spectacular Affair,

HAVY AND ARMY CO-OPERATE

Troops Plunge Walst Deep Into the Water While Under Fire-Insurgents Flee on Approach Aguinaldo Preparing to Fly the Coop.

A Manila dispatch of November 10. 5:05 p. m., says that the landing of the American troops at San Fabian was the most spectacular of its kind since General Shafter's disembarkation at Daiquiri. The co-operation of the troops and the navy was complete. The gunboats maintained a terrific bombardment for an hour, while the troops rushed waist deep through the surf under a heavy but badly aimed rifle fire from the insurgent trenches and charged right and left, pouring volley after volley at the fleeing rebels. Forty Filipinos were captured, mostly noncommissioned officers. Seven insurgent dead and five wounded were found in a building, which had suffered considerably from the bombardment. The town was well fortified. The sand dunes were riveted with bamboo twenty feet thick, which offered a good cover.

On landing, the battalions formed in good order. Captain Buck, with Price's and Patton's companies, pursued the insurgents on the left into the bamboo thickets. On the right was a frail footbridge across the river, leading to the towns. General Wheaton, personally commanding, ordered a charge across the bridge, and Captain Howland of his staff, led Coleman's and Eliott's companies of the Thirteenth and Shield's company of the Twenty-third, who behaved splendidly under their first fire, into the town, which was found to be nearly deserted except by the aged and some Spaniards who had hidden in the buffalo wallows, and who came shouting detoward the Americans.

The troops camped in the rain during the night and in the morning General Wheaton established his headquarters in a church, and quartered his men in the houses

## FREE STATERS GET CREDIT

Said to Have Decimated an Entire Brit-

ish Regimen's

A London special of November 10th says: Another rumor emanating from Amsterdam sources, says: A British regiment was decimated Friday by Free Staters."

It is added that 600 of the British soldiers were killed or wounded and that 300 horses were captured.

Another one dated Saturday morning 4:30 a. m , says: "Complete silence has again fallen upon affairs in South Africa. The British public must perforce be content with the brief stereotyped report which the censor allows to filter through from Capetown. That this condition of things is no longer due to pressure of work or defective cables has been amply proved. The Eastern Telegraph company reckons that the real delay in transmission is about two days. It is evident, therefore, that censorship is responsible for the other two days of delay, which seems to befall the dispatches.

Moreover, the Daily Telegraph announces that its "appropriated" dispatch from Ladysmith, dated Monday, which the war officers published on Tuesday, was not delivered in Fleet street until yesterday (Friday) morning. It is believed that the war office received further dispatches last evening. but nothing has been published.

## HE REFUSES TO SURRENDER

Adherent of Andrade Defics the New President.

A Puerto Cabello, Venezuela, November 10 dispatch says: General Parades absolutely refuses any proposal to surrender, A conference was held today between the British, German, Dutch, and American captains here, and as a result W. W. Russell, secretary of the United States legation, was sent to discuss the matter with General Parades. and to try to effect an arrangement. He proved to be defiant and intimated to Mr. Russell that he was ready to fight any force General Castro would send against him.

A La Guayra, Venezuela, November 10 dispatch says: Francis B. Loomis, United States minister to Veneznela, has asked the commanders of the foreign cruisers off Puerto Cabello to act together in order to prevent Gen. Antonio Parades, formerly a commander in ex-President Andrade's army, who rofuses to recognize the authority of General Cipriano Castro, from bombarding Puerto Cabello, by bringing moral pressure to bear upon him. The British, French, German, Dutch, and American commanders will confer at Puerto Cabello and will take all proper measures to prevent Parades from sacrificing the lives of innocent persons. The United States legation will protect the French sisters of charity by special request.

Andrade is President. A Ponce, P. R., November 8, special says: General Andrade, deposed president of Venezuela, who has arrived at Sin Juan, is quoted as having said in an interview that he was still president of Venezuela and that he would soon return to that country.

Rhodes' Plan Advanced. The Berlin correspondent of the London Daily Mail says he has learned that the Samoan agreement contains secret clauses relating to South Africa, whereby the plans of Cecil Rhodes are advanced a step toward realization.

Mills Cnable to Work Full Time On Account of Scarcity of Water.

The paper problem is getting to be a very serious one, and the trouble is becoming acute. In a recent issue the New York Commercial, speaking of the

Never have paper manufacturers been so short of water as now, and it is currently reported that unless rains come soon in the eastern part of the country there will be a famine in paper of all descriptions. Jobbers are beginning to feel the effect of the prospective famine, and are trying to prevent their customers from putting in further orders. So serious has the matter become that all prices on paper are withdrawn and bills are stamped that all prices are subject to change without notice.

The worst situation is in New England, where the mills have so little water that they are closed down part of the time, and unless rain falls soon they will have to close entirely. Holyoke is especially afflicted. The Connecticut river hasn't been so low in years, and rain comes on in fitful showers, which amount to nothing. The same general statement applies to the entire Connecticut Valley. None of the mills on the river, of which there are a large number, have water enough to keep them running full time.

Maine has not felt the drought so severely, but the water is low in all manufacturing centers, and unless copious rains soon fall some mills will make but very little paper this winter.

New York state manufacturers have been more favored than most of the others, and a larger proportion of the mills are enabled to run full time. They are far behind in their orders, however, and the situation promises no immediate improvement.

In the west, especially Wisconsin, water is low and the output of the mills is seriously curtailed, and the prospect appears discouraging. Some manufacturers say that they will be compelled to stop work entirely if they

do not have rain. The shortage in paper could not have come at a more inopportune time. The demand for news was never so large as now, and is steadily increasing, it has been a great news year, and the dailies have been turning out larger editions than ever before, and there seems to be no prospect of a diminution in demand. For book purposes there is an equally strong demand, occasioned by the increased output of books. Prices on both book and newspaper are 10 to 20 per cent higher than they were three months ago, and quotations are not guaranteed for the day

they are given out. The prospect of a famine becomes the more serious when it is known that jobbers were never so busy as they are now. They are away behind in their deliveries, and more than one large jobber will not go near his office. Others will not answer the telephone for fear some buyer is going to put in a vigorous kiek about delay in filling orders.

Even the International Paper Company is cramped in its deliveries, and of its own customer's.

## BOERS BOMBARD KIMBERLY

No Loss Reported, but Investment is Tightening Stirring news Soon

The chief fact is the opening of the bombardment of Kimberly by Free State artlilery, which proved ineffective. The Boer investment of the town is tightening, and many skirmishes are reported. Advices from Orange river comfirm the report of the Free State troops' advance on the north of Cape Colony, but owing to the retirement of the British forces from the borderland no serious collision has yet occurred.
