Also the House bill granting pension to Juliette Hall, daughter of Commander Hall, late colonel of the Eleventh Iowa Infantry, passed.

Mr. Wright moved that when the Senate adjourn, it be until Monday.

The morning hour having expired, the Senate proceeded to the consideration of the Geneva award bill.

Mr. Sherman gave notice that when the Geneva award bill was disposed of, he would ask the Senate to take up the finance bill, reported Wednesday.

Mr. Ogdens, of the committee on Indian Affairs, reported without amendment the bill to enable Indians to become citizens of the United States. Placed on the calendar.

On motion of Mr. Washburne, the resolution offered in the early session by the late Senator Sumner, for the settlement of difficulties between nations by arbitration, was taken from the table, and referred to the committee on foreign relations.

The Geneva award bill was read, and the amendments proposed by the committee were agreed to. Mr. Edmunds, in explaining the bill, contended that the government had no right to distribute any of the money to insurance companies, as risks assumed by the companies were in the nature of speculation.

Mr. Thurman offered an amendment striking out the provisions for awarding money to the heirs of insured persons, unless it has shown the claimants entire loss from war risks exceeds the entire premium paid.

Mr. Thurman expressed desire and intention to speak upon the bill, and in advocacy of his amendment, but said he was not physically able to do so today, and in consequence of motion of Mr. Morton, went into executive session and soon after adjourned until Monday.

HOUSE

Mr. Hale withdrew the motion to lay the centennial bill on the table, and it was recommitted to the special centennial committee.

The Senate amendment to the bill for the relief of Mississippi sufferers was concurred in, and the House proceeded
