H. Ottorburg, who came from Germany as agent of the German bondholders of the Rockford, Rock Island and St. Louis railroad, which lately defaulted, returned from the West yesterday. He says that before leaving St. Louis he instituted preliminary proceedings to foreelose the mortgage on the road. The company's indebtedness amounts to \$9,000,000, nine-tenths of which is held in Germany.

Jay Gould went to Boston yesterday to sign the deeds and consummate the sale of the Narragansett Steambost Line. The purchaser is the Old Colony Railroad Company, and the price is \$1,500,000.


