Ex-Governor A. C. Shallenberger is probably elected Congressman of the fifth district over Silas Barton present member of Congress by a small majority.

W. L. Weesner was elected Senator of the 20th district over G. W. Hummel by a large majority.

Something to Remember

Regardless of the advantage which has come to the plains region thru the introduction of dry farming methods, forage crops are much more certain to mature than grain crops and are available only where there is live stock available to consume them. Kafir, feterita, cane and other sorghums are valuable in proportion as they can be utilized locally for live stock. The grains which are most normally grown, aside from wheat, are most profitable if consumed locally, as markets are likely to be uncertain and freight rates high.—Dean E. A. Burnett, Col lege of Agriculture.

Cotting's Drug Store Destroyed by Fire

Last Friday evening at about six o'clock, the stock of drugs owned by Chas. L. Cotting, was completely destroyed by fire, as well as the greater part of the jewelry stock, which was owned by J. C. Mitchell. The lower floor of the building was completely gutted, altho the upper story was not badly damaged.

The fire was the result of a chemical explosion in the basement, which took place after Will Arnold, a clerk employed by Mr. Cotting, had struck a match, in an effort to secure a better light, while engaged in drawing some paint for a customer.

The firemen were at the scene of the conflagration in a very few minutes after the explosion, but the burning of the chemicals, etc., produced a thick black smoke which greatly hindered their efforts. However, they succeeded in confining the flames to the lower floor, and the basement, and in getting the fire under control before it had spread to the adjoining buildings.

Mr. Cotting lost practically his entire stock, not even his account books being saved. He places the total value of his stock, which was owned by himself and Mrs. Stonebreaker, at \$10,000. He carried \$1,000 insurance on the building, and a \$1,000 policy on the stock together with \$500 on the fixtures.

Considerable of the most valuable articles of jewelry of the Jas. Mitchell stock, were removed at the early part of the fire, and at this time we are unable to state the amount Mr. Mitchell values his loss at. He carried \$3,500 insurance.

Dr. Stockman, who had offices over the drug store, fearing that the firemen would be unable to control the flames, removed most of his instruments and medical supplies, and places his loss at about \$250, with no insurance. Paul Storey and H. Nuerberg suffered small losses caused by the flooding of their basements, they occupying adjacent rooms.

The force of the explosion struck Will Arnold in the face, cutting a gash on his chin, and breaking off several teeth, but fortunately doing no damage to his eyes. He was given prompt medical attention, and while considerable bandaged up, is able to be on the streets again.

The insurance adjustors are in the city today, adjusting the loss, and we understand that both Mr. Cotting and Mr. Mitchell intend to again embark on the business sea.
