



Ann Holland was born in Radeliffe, England, October 21st, 1846, and died at her home in Red Cloud, Dcc. 23rd, 1914.

At an early age she joined the High church of Kngland and was a faithful member of the same uutil she came to

member of the same until she came to this country. On December 25th, 1865, at Radcliffe, England, she was married to John Harris. To this union were born eight sons and three daughters. Four of these children preceded the mother to the grave; three having died in in-

At the age of fortyone, she, with her husband, moved to a farm near Red Cloud, Nebraska, where they had since resided, until six years ago, when they moved to town on account of her fail-ing health. She had a stroke of paralysis on Sunday evening, Dec. 20th, and died Wednesday, Dec. 23rd, at the age of 68 years, 2 months and 2 days. Beside her husband she leaves to mourn her death five sons, William, of Giltner, Nebraska; Alfred, of Delivan, Wis:: Harry, of Guide Rock, Nebr.; Fred and Charles of Red Cloud; and two daughters, Mrs. Anna Thomas of Indianopolis, Indiana and Mrs. Emma Smith of Gillette, Wyoming; twentythree grandchildren and four great grandchildren.


