### Victory for Democrats

The election on last Tuesday proved to be one grand victory for the democrats as they elected the entire state ticket by a majority of six to ten thousand. U. S. Senator Hitchcock was re-elected. C. E. Samuelson will be our next state senator, while the republican candidate, M. F. Richard, won in the race for representative. James Hubert, W. H. Thomas and John Kutz were elected commissioners. The majority given the county candidates were as follows:

Edith L. McKelham, clerk of the district court, 517. Gertrude L. Coon, county superintendent of schools, 147. P. J. Munday, county attorney, 286. Frank Huffer, sheriff, 52. C. D. Robinson, treasurer, 142. B. E. Ferry, clerk, 8 (it will take official count to decide). A complete account of the vote will be given in tabulated form in our next week's issue.

### Council Proceedings

On Tuesday evening, November 7, Mayor Damerell adjourned the regular session of the Council to November 8th at 8 o'clock p. m. on account of no quorum, it being election night.

Wednesday evening Mayor Damerell called the Council together in regular adjourned session at the Council chambers at 8 o'clock. Members present: Kuntz, Hamilton, Saladen and Stevens. Minutes of October 3, 18, and 27 read and approved.

Report of S. R. Florence read and ordered placed on file.

On Petition of the H. E. Gries Drug Co., et al asking Council to cause to be removed the Chas. Lindley building on north side of the Kellogg block the Council ordered that the Marshal be instructed to notify Mr. Lindley to remove the building from the streets by December 1st.

Grant & Fulton engineers presented the estimate on work done by Ekker Construction Co. to date and recommended the payment of \$3500. The Council ordered warrant for this amount to be drawn on the sewerage fund when the proceeds of the bonds are received from the U. S. Trust Co. Council also ordered warrant for \$2000 to be drawn on Sewerage Fund the rate being 1/2 per cent of the amount, and in favor of Grant & Fulton for services under their contract.

A special meeting of the Council is called for December 5, 1916, at 7:30 p. m. to assess benefits derived or damages sustained on account of building side walk on south side of Lot 13 and west end of Lots 13 and 14, Block 22, Red Cloud, Mary H. Parker, owner.
