



Kansas City Stock Yards, Nov. 13, 1916. Beef cattle sold 25 to 50 higher ast week, stockers and feeders barely iteady. Today the run of thirty housand cattle would have sold stee-ly to strong, except that Chicago had ,000 cattle, ten thousand above the stimute, and 10 to 25 cents lower rices. Prices here were mostly tendy, worst sales 10 lower, stockers wices. and feeders same. Hogs sold stendy to 10 higher, theop steady. BEEF CATTLE.

Kansas fed branded yearlings sold at \$10.75, the best cattle here, but strictly prime heavy steers would go to \$11.50. Short fed steers sell at \$8.50 to \$9.75, Oklahoma grass beef steers, 1150 lbs., at \$8.10, same cattle \$7.80 a week ago, light weight Colo-rado beef steers, 900 to 1000 lbs, at \$7.50 to \$7.75, some caked Panhandle steers \$3.25. Local packers are shipsteers \$3.25. Local packers are ship-ping cows and canners to their plants here from St. Louis and St. Paul, be-cause of scarcity here. HOGS Hogs advanced 40 to 50 cents first of last week, but lost a small part of it at the finish. The market opened steady today, with 11,000 head here, and will also preach Suuday night at but good demand from order buyers the M. E Church. soon advanced prices 10 cents, top \$10, medium weights up to \$9.95, and lights \$9.90. The market has a strong foundation, and there is not much excuse for lower prices at this time. Average weights are light, indicating that good prices and feed scarcity are influencing too many shippers to mar-ket prematurely. Most of the hogs coming could be fed 30 days longer

profitably.

SHEEP AND LAMBS. Receipts of 5500 contained only a few good to choice lambs or sheep. Light receipts here enable sellers to secure strong prices regardless of the lower reports elsewhere. Market here was steady to higher today, while Chicago reported a decline of 10 to 15 cents. Nest lambs here sold at 11.60 to \$11.75 and fat ewes sold at 7.50. A feature last week was prime Kansas fed western lambs weighing 14 pounds at \$11.75, top for the week. Feeding lambs are scarce, at \$9.50 to 210.25.
