Decoration Day Observed

Despite the predictions of many pessimistic people fair weather prevailed in this vicinity last Friday enabling Red Cloud to observe Decoration Day. It found practically all of our citizens and many of our rural neighbors present for the program.

All of the business houses of the city closed at 1:30 p. m., and the attention of everyone was turned to giving honor to the memory of our departed heroes. A procession, headed by the band, and made up of the Boy Scouts, Old Soldiers and pedestrians, marched to the cemetery to decorate the hero's graves.

Returning, they assembled at the Orpheum, where the day's program was concluded. Judge Ranney presided. The musical program was in charge of N. B. Bush, who with his Community Choir rendered several patriotic songs. The invocation was given by Rev. J. L. Beebe. Hon. S. B. Kizer read the names of the one hundred and three departed veterans who are laid away in the local cemetery. The veteran's favorite, "The Gettysburg Speech" was given by S. R. Boyce.

The address by Rev. J. D. Hamill held the attention of the large audience during the time that he spoke. He touched briefly on the various wars that had been fought, and their cause, and cited the four important points necessary to insure a peaceful land—Democracy, Liberty, Loyalty and Union.

The writer met a large number of people, including Mr. Harry Michels and Grandmother Copley, two of the early residents of the county.

Here is the one place that I know about, in the world, where the interest in education stops every other business and calls every person of a whole community to the school to bid God speed to the young people who leave its classes.
