## Farm Bureau Notes SCRUB PURE BREDS

Pedigrees do not make animals. In every family of pure bred live stock some scrubs occur. The registration of an animal is not necessarily a guarantee of its own excellence; it merely indicates what the animal has behind it. It may or may not be reflected in the animal itself. Naturally, most of the registered animals are good individuals and they have the ability to transfer the characteristic which they have inherited to their offspring, but there are a good many scrub pure breds.

Occasionally a farmer refers to an ordinary bull or boar which he has purchased at a very normal price but at a high price, considering the mdividual as a pure bred, or he will confide in proud tones that the animal is eligible to registry. Many of these animals actually could not be registered, but even though they were they could be picked as scrubs as far as they were visible. A man wastes money when he pays more than scrub prices for scrub pare-breds. Wellbred grades in many cases would be a better purchase.

Of course, pedigrees are valuable and they must be considered. Men who know pure-pred live stock could not use an individual, no matter how excellent it was unless its pedigree were above suspicion. However, good breeders are just as careful to eliminate scrub pure-breds. The fact that an animal comes from registered There is a possibility that it does, but occasionally there are sports from pure-breds which revert to the very commonest kinds of animals. The farmer should be very careful in selecting breeding animals and he should be able to tell whether or not the animal he expects to buy measures up to the quality indicated by the pedigree. Do not purchase an animal which is " eligible to registry" merely upon the statement of its owner. If the animal is eligible there must be very definite proof of the fact at hand. If you are expecting to purchase a pure-bred animal, do not purchase one that is merely eligible to registry, but make the seller or breeder provide the papers. Above all avoid scrubs. Learn to discriminate between the good pure-bred and the scrub pure-bred. Cull your flocks as mercilessly as though they belonged to another. Retain only those which will improve the breed. If this be done, your reputation as a breeder and your financial standing will be assured.
