ARMERS DISCUSS MERITS OF FARM BUREAU MEMBERSHIP Problems and questions of vital importance to the farm bureaus of the middle west were discussed by the Mid-West group at the regular meeting held at Lincoln, January 26th and The states represented were: Illinois, Indiana, Michigan, WWW. Kansas and Nebraska. Elmer E. Youngs, president of the Nebraska Federation, was chosen as chairman of the meetings and Chas. R. Weeks, secretary of the Kansas Federation,

Closer co-operation between the form bureaus and the department of agriculture was practically assured fellowing a discussion led by Ivanhoe Whitted of Iowa, when a resolution was passed urging the need of an appropriation of sufficient volume to carry on the work of collecting, tabulating and disseminating statistical information so vital to the farmer, breeder and feeder.

Several farm bureaus have maintained statistical departments in securing data on live stock in the different states but the sentiment prevailed that such work was more or less of a duplication of the efforts of the bureau of crop estimates. Members of the bureau of crop estimates pointed out that work similar to that undertaken by the farm bureaus had been planned by their department but they had been handicapped by lack of funds. The bureau was represented in the discussion by Frank S. Pinney, of Iowa, E. C. Paxton of Kansas, Geo. C. Bryant of Indiana, and E. A. Logan of Missouri.

Some criticism was made of the reports and bulletins issued by the department of agriculture. It seemed to be the opinion that the farmers were not securing practical benefit from them, chiefly through their own fault. It was suggested that the farm bureau establish some system of getting these figures and information to the farmers in a more practical form.

Progress of the legislative departments of the different federations was given by Howard Leonard, president of the Illinois Agricultural Association; R. Morrill, president of the Michigan federation; and C. W. Hunt,

Notice to Owners of Dairy Cows

Tife Dairy Law of Nebraska requires that all cows from which any milk or cream is sold for consumption shall be tested at least once each year by an approved veterinarian. The only exceptions to this are in cases where milk or cream is delivered to a dairy where the product is properly pasteurized before it is sold to the public, or where the entire product of the herd is sold for manufacturing purposes.

Cow owners are urged to bave this testing done during the months of January and February for the reason that more time is available, and when a number of cows are assembled at one time and place. reduced rates for testing will be made. The law provides this testing shall be done by an approved veterinarian and the following are the approved veterinarians in this district.

Arrangements should be made to have this testing done within the time specified, as the dairy inspector will check all cow owners are required to test. Attention is called to the fact the Dairy Law provides a penalty for failure to comply with the above provisions.
