
Section 2. (Ballots.) That at the general election nineteen hundred and ten (1910) there shall be submitted to the electors of the state for their approval or rejection the foregoing proposed amendment to the constitution S. At loosing two ricks of alfalfa by spontan- such election, on the ballot of each posed amendment, shall be written or printed the words: "For proposed amendment to the constitution relating to the right of suffrage," and "Against said proposed amendment to the constitution relating to the right of suffrage."

Section 3. (Adoption) If such amendment shall be approved by a majority of all electors voting at such election, said amendment shall constitute section one (1) of article seven (7) of the constitution of the State of Nebraska.


