PARTY MUST ACCEPT

COLONEL ROOSEVELT PRESENTS DECLARATION OF FAITH.

PUTS CURB ON CONTRIBUTIONS

New Treasurer of Democratic National Committee-Will Limit Political Contributions - Investigating Police Blackmail.

New York.—The national progressive party must accept Colonel Roosevelt's political doctrines if he is to be its standard bearer. He said as he started for Chicago that he would insist upon making his "confession of faith" to the delegates before the committee which is to draft the platform comes in with its final report and that he would not accept the nomination on a platform which did not meet with his approval. His declaration of political faith, he said, is one which will be termed either socialism or anarchy and probably both, but he represents his convictions. He goes to Chleago to make these views known and to receive the presidential nomination only if they are acceptable in their sub stantial provisions to the new party.

CURB ON CONTRIBUTIONS.

Further Limitations Incorporated in a Senate Bill.

Washington. - Further limitations curbing contributions to presidential campaigns have been incorporated in a bill agreed on by the senate committee on privileges and elections and reported to the senate for passage. Predictions were made that it would be enacted into law at once. Contributions of individuals to such nominations or elections would be limited to \$5,000, but this provision would not apply to candidates themselves. Under the present law, candidates for congress are limited to spending \$5, 000 in nomination and election and candidates for the senate \$10,000.

New Democratic Committee Treasurer Seagirt, N. J.-Charles R. Crane of Chicago, manufacturer and supporter of LaFollette in his campaign for the republican presidential nomination, may be treasurer of the democratic n tional campaign committee. Governor Woodrow Wilson has had the name of Mr. Crane under consideration. The only announcement the governor would make was that a treasurer had been agreed upon by himself and National Chairman McCombs, but that the name would be withheld until it could be determined whether the man in view would accept.

To Is restigate New York Police.

New York.-The revelations of the Rosenthal murder case, pointing to the existence of a system of police blackmaff levied upon illegal resorts, prompted a number of leading citizens to issue a call for a public mass meeting at the Cooper union this week to adopt plans "to make effective public demand for the observance of law and order in this city." A popular subscription to provide funds for an investigation and the employment of lawyers and detectives is included, it is understood, in the plans of the committee

FOREIGN NATIONS MUST NOT EN-CROACH ON US.

BETTER DIKES IN THE MISSOURI

Improvements to Be Made Near De catur, Nebraska - Revolutionary Movement Causes Anxiety-

Gold Finds in New Mexico.

Washington, D. C .- The United States senate has issued a warning to the nations of the world against encroachment upon the continents of North and South America. The United States will not see "without grave concern," said the senate, "any suitable naval or military site pass into control of a foreign corporation, when such possession might threaten the communications or the safety of the United States," So vital were the issues discussed in the Lodge resolution set forth that the policy of the United States as to points situated like Magdalena bay, in Lower Callfornia, that the doors of the senate were closed for three hours, while the resolution was debated in secret session. It finally passed with only four votes against it.

To Improve Missouri River. Washington, D. C .- Eight thousand dollars is to be expended under the direction of the war department upon the dikes of the Missouri river near Decatur, Nebr., according to the cecent recommendation of Major Schultz, engineer in charge. This sum will be set aside from the appropriation of \$75,000 for the upper Missouri contained in the river and harbor bill. The high water this spring did great damage to former improvement work near Sloux City and Decatur, and the recommendation of Major Schultz and the war department is made after an examination of the situation.

PASS BILL OVER TAFT'S VETO NEW RULER OF JAPAN BUSY MAN

SMALL PROSPECT OF CANAL OPENING NEXT YEAR.

Large Portions of Earth Float Down River-Federal Treops Advancing on Rebel Stronghold-Fishing

Boats Are Seized.

Washington, D. C .- Unless congress takes action to provide for the operation of the Panama canal at the present session, President Taft and Secretary of War Stimson believe it will be practically impossible for the army engineers to keep their promise to open the big ditch to the ships of the world next year. According to the information brought to the White house Wednesday, the prospect of action by congress on canal legislation at this session is growing dimmer. Mr. Stimson was understood to believe that there is little connection over the proposed administration and the operation of the canal and the question of tolls, and of railroad-owned steamships. which have stirred up controversy in both houses and today neither the president nor his secretary of war was hopeful of settling it. The Panama bill was put aside again in the senate after Senator Brandegee, who is guiding it, stated that adjournment probsidered in the senate while the postoffice bill was in conference.

Federal Troops Too Hasty.

Washington, D. C .- Advices received at the state department from private sources Wednesday indicate that the federal troops that are advancing upon the rebel stronghold at Casas Grandes in Sonora are exposing themselves to a disastrous defeat Albuquerque. N. M.-A score of through their haste to surround and capture the Orozco forces. The situation is said to approach that existing at Corrillitos several months ago when General Salas, the Mexican minister of war, leading a dashing campaign, was practically trapped by the rebels.

Doctrine to Be Reaffirmed.

Washington; D. C .- The senate foreign relations committee Wednesday adopted without dissent Senator Lodge's recommendation that the United States reaffirm the Monroe doctrine in terms clear to all the world, and adopted a resolution to express disapproval of the purchase of any possible naval bases on the American continents by any foreign power.

Minister is Deposed.

San Salvador. - Dispatches from Managua report the deposition of General Mena, as minister of war by President Diaz. The government forces captured the Campe de Marto barrack. which dominates Managua. General Mena fled to Rivas, which is not far from San Juan Del Sur and is in possession there with a considerable force under his command.

On Wrong Side of Line.

Vancouver, B. C .- Six Frazer river salmon fishing boats were seized Tuesday off Point Robert by a United States revenue cutter on the ground that they were operating in American waters. The occupants of the boats asserted that they were on the Canadian side of the boundary.

Washington, D. C.-Following bitter criticisms of President Taft by Senator Cummins of Iowa, the senate Wednesday afternoon, by a two-thirds vote, overturned the executive's veto of a reimbursement bill in favor of sub-contractors on the Shoshone irrigation project, and re-passed the measure. The vote was 42 to 17. This is the first time during the Taft administration that the senate has passed a bill over the president's veto. The measure will now go to the house.

River Devouring Nebraska Town. Tekamah, Nebr.-The people of Decatur, north of here, are again fearful

over the inroads that the Missouri river is again making on the town. During the past few days the situation has become alarming, as huge slices of the north end of main street can be seen sliding off into the old Muddy and whirled out of sight. The river is cutting away between the second and third dike which the government reinforced last spring. If the cutting is not stopped the entire north end will soon be in the river.

Turkish Government Willing to Negotiate for Peace-Boston Railroad Strike is Settled-Senator

BILLS BACK UPON SENATE.

Washburn Dead. Washington, D. C .- With machine-

like precision the democratic house Tuesday forced, over all opposition, three tariff measures back upon the senate. They were the wool and sugar tariff revision bills and the excise tax bill and all were sent back with none of the senate's amendments accepted. On the wool bill no conference was asked. The house left it flatly to the senate whether that branch desired to pursue the legislation further. The senate was in a quandary as to what program it would adopt in further consideration of the three bills. The regular republicans were reported to favor a plan whereby they would absent themselves from the chamber, thus giving the democrats a chance to pass the measures and send them along for the presidential veto. The republican "insurgents," however, opposed this scheme and insisted that the differences, where they are reconcilable, be threshed out in conference.

Willing to Make Peace.

Constantinople.-The Turkish government is willing to enter into peace negotiations with Italy if they are conducted in a manner compatible with Turkey's honor and dignity and her rights are adequately safeguarded. This was announced in the chamber of deputies here Tuesday during the reading of the ministerial program.

Will Call Extra Session.

Tokio.-Mikado Yohoshito, Japan's new ruler, decided Tuesday night to call an extra session of parliament soon. He wants to tell his subjects that it is his ambition to continue the modernization of Japan. With parlinment in session he can outline his nellcles with the least possible loss of time to the largest possible number of the country's most influential man.

Strike is Ended.

Boston.-The strike of the conduc tors and motormen of the Boston Elevated Railway company, which has lasted for fifty-three days and is estimated to have cost \$1,028,000, was ended Monday night by the agreement of the company officials to the terms of settlement the strikers winning every point sought.

Committee to be Abolished. Elgin, Ill.-Announcement has been made that the Elgin board of trade would abolish the quotation committee as a result of the threatened government suits against the members of this committee for alleged violation of the Sherman anti-trust law. The suit now pending against the Chicago butter and egg board and threats that a similar suit would be filed against the Elgin board also are said to have figured as reasons for the action.

Indianapolis, Ind.-Governor Thos. R. Marshall will be notified of his selection as the democratic nominee for vice president of the United States or August 20 at the coliseum at the state fair grounds.

Former Senator Dies. Minneapolis, Minn.-Former Sena-

With his fighting blood riding on the crest of a beer-foam spree, James Ridgeley, a farmer, residing twentytwo miles northwest of Fremont, drove his wife and two children from their home at midnight, brandishing a butcher knife and threatening them with extinction. They ran to the home of a neighbor whence a telephone call brought Sheriff Condit, who arrested the offender.

Godfred Hulshizer, at present residing in Kansas City, but formerly of Wymore and later of Lincoln, had quite an exciting experience with burglars at his home. He and his wife were awakened by their noise and on arising to investigate were covered with an electric flash light and guns in the hands of the two intruders. The robbers got two gold watches and a few other valuables,

The animal was tled in the barn when Sage went behind it without speaking.
