Put it down, then, that, barring exexceptional cases which merely prove the rule, freedom of judgment and choice to the extent of taking the right path or the wrong path is within the power of each one of us, and that the general level of good citizenship will be raised only by bringing moral standards of the individual up to the proper exercise of this power .- Oma-
