"Under the present law fiquor to be shipped in interstate commerce must be plainly labelled, and when it is sent to anyone known to be in the business illegally, everyone can see what it is when it is taken off the train at the depot; but no one can take it because nutil its delivery it is in interstate commerce and under federal laws not subject to seizure. This bill destroys its interstate character. It fixes no punishment, but if the state law provides against liquor selling it can be seized before delivery, and the state authorities must then prove that it was

intended for illegal purposes before they can convict. "The burden of proof is upon the

state or individual seizing the liquor to show that it has been shipped in for purposes contrary to law. Any liquor sold to a licensed dealer cannot be touched and in no way is the shipper of liquor, whether it be consigned to a licensed dealer or a boot legger, affected by the provisions of the Kenyon-Sheppard bill - Monday's State Journal.

Nebraska Potato Diseases

The Department of Agricultural Botany is now completing for publication an extensive bulletin on the nature and control of the dry rot of the potato -a disease prevalent in the sand hill and high plains regions of western Nebraska. The disease has been shown to be due to a parasitic fungus, which enters the mature tubers through

It has been found possible by proper treatment before storage to reduce the losses from this rot from 30 to 40 per cent down to only 3 or 4 per cent. The western Nebraska potatoes have excellent "baking" quality, and by the use of these new methods it should be possible to hold; these potatoes through the winter and avoid the losses due to immediate sale of the entire crop in the fall. 
