By O. H. T. HERRICK. The London Times gives the following account of an Irishman, who is described by a correspondent as the chief adviser of Jobbert, the Boer commander. It was for some time connected with James Stephens, the Fenian leader. A correspondent of the Times, who was in Natal last year, writes that he was told him how he had secured his connection with the Fenian movement in Ireland. His story was substantially as follows: At a meeting of a central committee, Stephens presiding, at which Aylward was present, it was decided to assassinate the late Lord Mayo, then chief secretary for Ireland, as he passed out from the castle yard in Dublin, and to attack Chester Castle for the purpose of procuring arms. Aylward disapproved these plans, and he thought the time for assassination had not yet come, and informed the committee of his dissent. Aylward then wrote a note to Lord Mayo, and he did not pass through the castle yard that evening. Aylward was then shot by a Fenian as an informer, and was taken to the hospital, where he died.
