The Extraordinary Levy Made by Congress at the Opening of the Rebellion.

How the Democracy Depleted the Treasury—The Claim of Nebraska Against the Government.

OMAHA, Neb., July 11, 1883.

To the Editor of the Bee: Sir: The 36th congress, in 1861, found that the democratic party previous to going into secession and rebellion, had raised into the United States treasury to such an extent, and so depleted its resources, that an emergency arose that had never been known in our history.

Provided, That the sum of \$19,312, direct tax, laid upon the territory of Nebraska by said act, shall be paid and satisfied by the said territory out of the appropriation for legislative expenses of the Territory of Nebraska for the year ending 30th of June 1863, and no further claim shall be made by said Territory for legislative expenses for said year.

The amount which will appear on the books of the treasury department will be withheld by the United States, but the proper officers neglected to carry it out as provided, in the act of the State with the U. S.

This was quickly done, as this system of discharging the surplus revenues of the country at once met with popular favor, and, as the loans were to be without interest, none refused to accept. The States, upon receiving the money, which was paid in four installments, adopted various methods of using it. The most common manner of its disposal, however, was by lending it to individuals upon real-estate mortgages.

These are the only three financial transactions of this nature between the States and the government. The last two furnish an argument for our statement to the effect that it will come up soon after the meeting of congress. How to do justice to all the states and how to collect and divide on equitable terms, is the question.
