The King of Spain Accepts the Apology of France and Starts for Home.

The Courts and Press of Europe Discuss the Latest French Outrage.

The People of Spain Resent the Insult by Speech and Resolution.

"THE UHLAN KING."

LONDON, October 1 .- A Paris correspondent says: The people came almost to the windows of the King's carriage hissing and groaning. A woman broke the carriage. The men were apparently beside themselves with rage. They shook their fists in the very windows of the carriage. Even where the attitude of the crowd was least aggressive, there were no words of greet-The Paris Figaro, in the name of French dignity and politeness, pretests against the manifestation. The Gaulois says the demonstration was worse than a mistake. It was worse than crime. The Clerica describes it as an act of savagory

and a disgrace to the country.

The Intransegeant says: Spain will know that in King Alfonso it was not the Spaniard who was hooted but the German. The King's position was so dangerous at the railway station that all Spaniards drew their swords. A Spanish military attache was prevented by his companions from leaping from the car-riage to avenge the insults offered to the King. Alfonso dispensed with the services of President Grevy's Aid-de-Camp, and walked this morning along the

Boulevards with only an attendant. President Grevy, being informed that the king would not attend the banquet at the Palace Elysee, yesterday visited him and made an humble apology. The king accepted the apology, but said if he stayed longer in Paris that he hoped, as the outrage had been public, the reparation would also be public and that the apology be published in the official journal. He returned from the banquet at the Palace Elysee at 11. There was no public demonstration. It is rumor-ed that Prime Minister Ferry and his colleagues threatened to resign unless President Grevy apologized to King Alfonso for the hostile The whole German emmonstration. bassy visited the King in uniform yester-

AFFAIRS IN CANTON.

LONDON, October 1 .- A Canton dispatch reports the Chinese viceroy has written an official note to the English consul at Canton, complaining of the result of the trial of Tide Waiter Logan as being a miscarriage of justice. The consul points out that the real cause of the viceroy's complaint is that the prisoner was fairly tried instead of being condemned to death unheard. Business is entirely suspended in Canton, and the Chinese are leaving the city in great numbers. SPANIARDS GROWING WARM.

LONDON, October 1. - The Madrid correspondent of the Times says: The hos-tile reception accorded Alfonso in Paris, has considerably increased his prestige at home. His personal courage and discretion, his dignified bearing during his walk in the streets of Paris and his visit to President Grevy's residence at Elyse without escort, are subjects of general eulogium and admiration by the Spaniards. The citizens are highly incensed over the insults offered Alfonso in Paris. Bands of people paraded the street yesterday evening, insulted French men and openly threatened the French embassy. The police prevented violecne. Senor Wanet, at a meeting of the Democratic club, declared the insults offered to the king affected the whole Spanish nation, which would stand by the king His utterances were received with loud

cheering.
Marshal Serrano telegraphed Senor Conovas Del Castello that the cause of the monarchy demanded his presence in Madrid. Officers of the garrison also held a meeting, at which strong speeches against France were delivered.

Alarming reports prevail that Spanish cabinet will demand of the French government a public apology for the insult offered Alfonso, and the Ger man government will make remonstrance at the indignities to which the Spanish king was subjected.

Alfonso was quite unaware of his ap pointment to a colonelcy of the Uhlar regiment until he received it and his uniform simultaneously. Emperor William intended the appointment as an agree-able surprise. He would not lend himself to anything that would be likely to excite prejudice against one for whom h had taken exceptional liking.
