WHEREAS, The bar of this district by an almost unanimous voice have signified their wish that this principal be carried into effect at the approaching election by the choice of the present incumbents of the bench of the Third Judicial District; and

WHEREAS, We believe that such action will tend to maintain the purity, impartiality and integrity of the bench, the reputation of the bar and the welfare of litigants and citizens generally, therefore,

Resolved, That we nominate as our candidates for Judges of the Third Judicial district, Messrs. Wakeley and James Neville, then in session, and communicate to them the act of said Democratic convention.

The convention then declared George W. Sueland and C. H. Brown, of Douglas, Martin Longdon, of Sarpy, Dr. E. Palmer, of Washington, and N. J. Sheckell, of Burt county, to be the District Central Committee for the ensuing year, and then adjourned.
