W. Ristine, traffic manager of the St. Louis & Texas; J. H. Hiland, general freight agent of the Chicago, St. Paul, Minneapolis & Omaha; George Olds, freight traffic manager of the Missouri Pacific; John Cramp-ton, of Chicago, formerly freight agent of the Vanderbilt line, and George Alexander, vice president of the Louisville & Nashville. A unanimous vote is necessary to elect. On the last ballot Rockwell had all except one; the others who showed strength at various stages were Alexander, Ristine and Ripley.

A DAKOTA RAILROAD WAR.

FARGO, Dak., October 31.—There is great excitement at Wahpeton over the refusal of the Manitoba railroad to deliver forty-seven cars of freight to the Fargo and Southwestern railroad at Wahpeton yesterday. The freight was material for construction of the Fargo and Southwestern railroad, and the cause of the dispute is supposed to be opposition of the Manitoba to the new road. Eleven cars of ties were taken possession of by the Fargo and Southwestern men, but they were attacked by 300 Manitoba workmen, and the cars recaptured. The Manitoba road has prevented the new road from completing its road-bed at Wahpeton, and the Fargo and Southwestern to-day made application for an injunction prohibiting the St. Paul, Minneapolis and Manitoba railroad from entering upon or interfering in any way with its road-bed or right of way at Wahpeton. The complaint alleges that the Manitoba road has title to the ground upon which the road-bed is located; that the Fargo Southern is the owner in fee simple of the right of way where the two lines intersect and that the Manitoba road has caused an embankment to be turned back on divers occasions as fast as built up; that in addition to this alleged maliciousness, the Manitoba road has maliciously interfered with the rights of the Fargo Southern. A telegram from Grand Forks states that Judge Hudson has granted the injunction asked for, restraining the Manitoba from in any way interfering with the Fargo Southern or entering upon its lands.
