LAND GRABBER VAN WYCK.

To afford an idea of how big a thing may appear in dim perspective that distinguishes the magnificent distances that characterize the national capital, we produce a floating paragraph from a Washington paper: Senator Van Wyck a few days ago called the attention of President Cleveland and Secretary Lamar to the fact that several citizens of Nebraska were recently murdered while trying to take homesteads on public lands illegally fenced by a British cattle company.

Mr. Kountze asks \$800 a year for the market house site for five years, that at the end of which period there is to be a reappraisal of the property.

The sum of \$800 is six per cent. on a valuation of \$13,333. Suppose the property by reason of being the market-house site should be greatly increased in value, and re-appraised at the end of five years at \$30,000, or at the end of ten years at \$60,000, we would then have to pay, at the rate of six per cent., an annual ground rental of \$1,800 or \$3,000, as the case might be. This would be altogether too much for the city to pay.

STREETS, for assignment to their proper and respective positions.


