"The statement of Mr. Bell that he accomplished just what he went to Detroit for, namely, the jarring loose of the Baltimore faction from the American Federation of Labor, is an absolute lie. Every body knows that the Baltimore faction is a body of men who have joined the American Federation of Labor and in order to place both factions on an equal footing the resolution was passed by the federation to hold the charter of the Baltimore faction in abeyance pending negotiations. If Mr. Bell wants to see the two factions come together why does he continue to abuse the Baltimore faction? Why does he yet proclaim that there will be a dissolution of that faction? If the Baltimore faction is to be dissolved there would be no amalgamation, but an absorption. The Baltimore faction has always been willing to amalgamate, but the Lafayette faction has always insisted upon absorbing the Baltimore faction. The resolution as passed by the federation is as follows: 'Resolved, That the executive council, or those who shall have charge of carrying into effect the provisions of resolution 91, as amended, are hereby instructed to suspend within thirty days from date of adjournment the charter now held by the Brotherhood of Painters of America, commonly known as the Baltimore faction; and, be it further

"Resolved, That in case there be no consideration representation at the proposed convention other than said Baltimore faction, then said committee is instructed to at once renege said charter."

"Would it not show better faith on the part of Mr. Bell if he would stop harping upon his alleged work at that convention and assist in the amalgamation? We want amalgamation, and we want the right to stop in the interest of organized labor, and therefore we would suggest that Mr. Bell stop his warfare pending the negotiations. If Mr. Bell wants to be wholly fair in the premises why doesn't he have his union withdraw from the Central Labor union pending the settlement? All we ask is that the fight cease and that we give a fair chance."

CELEBRATION BRINGS DEATH

Coroner's Jury Finds that Martin Flaherty Was Shot by Frank Derr.

ENGAGE IN STOCK BUSINESS

Deputies Palmer and Barber of United States Marshal's Office Are Buying a Knuck.

The inquest on the death of Martin Flaherty was held yesterday in the undertaking rooms of Healey & Healey under the direction of Coroner Stanton. The result of the coroner's jury was as follows: "We find that Thomas Flaherty came to his death on the 26th day of December, 1899, at St. Joseph's hospital, as the result of a gunshot wound inflicted by a leaden bullet fired from a gun in the hands of Frank P. Derr December 24, 1899, at the intersection of 15th and South Omaha. We further find that said Derr fired the shot with felonious intent. (Signed) Moses P. O'Brien, P. C. Healey, B. H. Smith, J. F. Lindsay, Jerry Howard, L. H. McLarnan."

The principal testimony in the case was taken from William Aikens, who was in the room at the time of the shooting, and who, pointing to the whole affair. According to his story the four men—Thomas Conroy, William Ryan, Al Keenan and Martin Flaherty—were celebrating Christmas eve in Conroy and Ryan's room by drinking three quarts of whiskey which had been a present to one of the boys from a saloon keeper. This room is in the Hunt block and adjoins a room occupied by Derr and his wife. There is a door between the two rooms. Ryan admitted that during the evening the four probably made a great deal of noise, but said there had been no objection from Derr previous to the time of the shooting, and although he came in before he merely asked if they were enjoying Christmas eve. Derr finally came and told them they would have to leave as they were making too much noise. Ryan said that then he and Flaherty were the only ones awake, and they both started toward the door, remarking that they wished to go home. Derr followed them and, pointing to Flaherty, said: "That man has a gun." Ryan, to prove the statement false, stopped his friend and patted each pocket flat. Derr then came near the two and fired two shots. Both took effect in Flaherty's abdomen. Ryan swore that both he and Flaherty were in the room at the time.

The attorney for the defense, who was present, would not say what the defense would be, but his questioning indicated that it would probably be self-defense. The testimony of the other witnesses was unimportant.

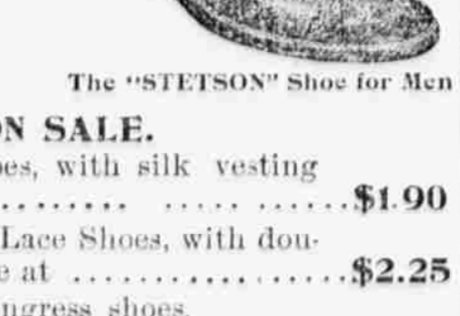
