A comparison of this report with those of the former oil inspector, J. H. Edmiston, shows that J. H. Gaffin turned into the treasury during seven and one-half months nearly half as much as Edmiston turned in during his entire incumbency of four years and also indicates what an appalling state of rottenness existed in the oil inspector's office while the latter was in charge.

Only a few months after Edmiston assumed the duties of his office, over four years ago, he sent in to the auditor a bill of expenses for a trip to a point in southwestern Nebraska, while his report of work done showed that on the day he made the trip he inspected 117 barrels of oil in the northern part of the state. It was erroneously reported in a local sheet that has for several months been endeavoring to secure the good will of the auditor's office, and incidentally the publication of an annual insurance report required by law, that Mr. Cornell would withhold the license of these companies until they made good the shortage of his predecessor. It was asserted that such action would be taken to save the taxpayers of the state the expense of endless litigation.

Auditor Cornell is in favor of allowing the courts to divide the liability among the various companies that were licensed by Moore. Of the fees collected by him about \$9,000 was paid into the treasury, and what companies deserve credit for incorporation he thinks is a question that should be referred to the judiciary.
