


-World-Herald Phot Tot Crosses Atlantic Alone



Operated by three wet-cell batteries, the auto has variable speeds and is ideal for a phys-ically handicapped person. It is the same type vehicle used by many on golf courses.


No Abstinence for **Catholics on Friday**




