Services Held At Verdigre For Mrs. B. Sukup



Officials Release O'Neill Mill Levy Comparison

Voters will be asked to decide November 8 whether the O'Neill public school board should issue \$465,000 in bonds to buy a site, build and furnish a new school. The first legal notice of this election appears this week in the Frontier.

School officials said this week that by 1964 the school would lose \$84,000 annually in free high and grade school tuition if no new building is constructed.

Present enrollment in grades five through eight would crowd out tuition students to cause the loss in income, Supt. M. J. Baack said. Costs will remain constant, he added, even though tuition students are not in school, and the \$34,000 loss will have to be raised through increased taxes. This would increase the levy by about seven mills, based on 1960 valuation figures of \$4,727,332 for the district.

"We are going to pay for a high school whether we build it or not," School Board Secretary L. Lindberg said. "When we lose that \$34,000

from tuition we'll have to raise it by taxation. We can build a new school for about a seven-mill levy or make up a deficit and have no new school for seven mills."

Elementary enrollment figures have increased steadily since 1955. Total enrollment through the eighth grade now stands at 460 pupils, just 99 more than in the 1955-56 school year.

Today's eighth grade now stands at 50; seventh, 47; sixth, 47 and fifth, 50. When these eighth graders are seniors there will be 194 students in high school to crowd out an estimated 65 tuition students.


At present 173 students are enrolled in high school including 118 from the district and 55 tuition students. Arden Uhlir Named Nation's Star Farmer



Arden Uhlir, Verdigre FFA member, was named Wednesday as Star Farmer of America, FFA's highest honor.

LINCOLN—Arden W. Uhlir, a 20 year old farm youth and son of Mr. and Mrs. Otto W. Uhlir, Verdigre, was named Star Farmer of America at 8 p.m., October 12 at ceremonies conducted during the second session of the 1960 National FFA Convention, held in Kansas City, Mo., at the Municipal Auditorium.

This is the highest individual honor bestowed upon an FFA member by the national organization, composed of 380,000 members, belonging to 9,000 local chapters throughout the nation.

Arden started his farming program in his freshman year in high school, with three head of Herefords, three head of hogs, and 15 acres of corn. He now farms 640 acres of land, consisting of 67 acres of alfalfa, 65 acres of oats, 65 acres of corn, 90 acres of hay, 10 acres of sudan, and 320 acres of pasture, the balance in farmstead and wooded area.

Along with this, Arden has developed an excellent registered Hereford beef cattle herd, which now numbers 78 head, has 20 Landrace sows which he has on a farrowing program of 10 sows every three months, plus 3 good producing Holsteins. In addition, he has machinery and equipment of his own. His net income to date totals \$24,748.28.

Arden was named Star State Farmer of Nebraska at the 1957 State FFA convention. He also served as State FFA president in 1958-59, and has now completed 7 years in the Future Farmers of America. He was a member of the Verdigre Young Farmer class in 1958-59 and the Adult Farmer class in 1959-60. He is a member of the American Hereford Association and the Nabrara Valley Hereford Association.

He has served six months military duty, from October through March, 1958 at Fort Knox, Ky., returning in time to attend and participate in the 1958 State FFA convention. He is now a member of the Nebraska National Guard. In the fall of 1960 Arden was the recipient of the Knights of Ak-Sar-Ben Citation medal given to the most outstanding soldier within his regiment of the Nebraska National Guard.

Arden was married in June, 1960, and he and his wife, Karen Faye, are now farming the 640 acres of land near Verdigre. His wife, Karen Faye, brother, Neil and his parents, Mr. and Mrs. Otto Uhlir were in attendance at the convention to see this honor bestowed upon him. Arden's present FFA advisor is Ted D. Ward.
