### Four Bids Received For Ainsworth Canal

Bureau of Reclamation Construction Engineer, R. L. Boyce, announced today that four bids were received for construction of the Second Section of the Ainsworth Canal.

Bushman Construction Company, St. Joseph, Mo., submitted the apparent low bid of \$2,384,997.50. The engineer's estimate was \$2,583,432.00. Other bids were received from Sweetman Construction Company, Sioux Falls, S. D., \$2,456,001.65; Missouri Valley Construction Company, Grand Island, \$2,489,000.00; J. H. Beck Construction Company, Sioux Falls, S. D., \$2,600,000.00.

The second section will be 14.3 miles long and lined with concrete. It will end about a mile west of Highway No. 83.

Award of the contract by the Assistant Commissioner and Chief Engineer, Denver, Colo., is expected the latter part of May.

### Orchard School Bond Issue Gets Approval

Voters of Orchard school district 49 Tuesday approved, 184-64, a bond issue of \$120,000 for construction and furnishing of an addition to the present schoolhouse.

The 15-year bond issue will require an additional tax of 7.34 mills on residents of the district unless the valuation of the district should be increased by further consolidation.

An addition 80' x 144' is planned to the west of the present school building. It will include a gymnasium with stage, a kitchen for the hot lunch program, dressing rooms and rest rooms.

The addition will be constructed of brick walls with steel curtain walls and steel roof. The gym will include a standard basketball court with folding bleachers.

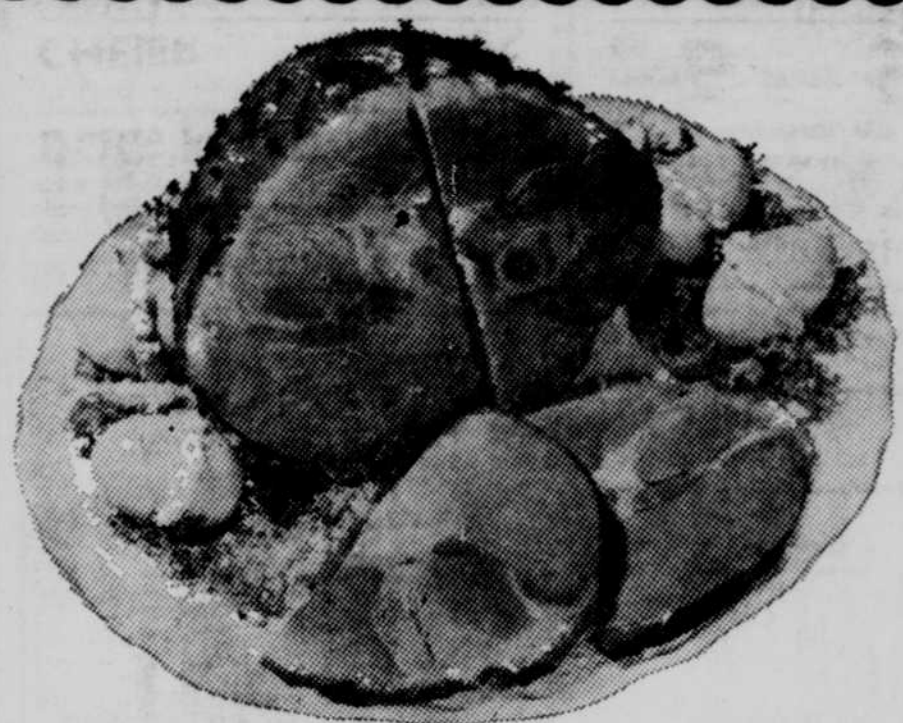
