

## Three Ranchers Named To Conservation Contest

Raymond Dexter, E. M. Jarman and Walter Fick have been selected to represent the Holt Soil and Water Conservation District in the Sioux City Permanent Agriculture contest. Entries are judged on the basis of proper land use, completeness and complexity of the conservation job.

Raymond Dexter operates 1163 acres southwest of Chambers. He has accomplished a considerable amount of blow out control by shaping, mulching and seeding and by fencing the most severe areas. He has constructed over a mile of cross fence to divide pastures into smaller units and to facilitate his rotational grazing system. During the time he has been on the place he has planted nearly 30 acres of trees for livestock protection.

E. M. Jarman, also located southwest of Chambers, operates 5520 acres. During the years he has made numerous seedings of grass both by the conventional method of drilling and also by aerial seeding. This past spring he planted 15,000 cedars for livestock protection and previously has underplanted many of the cottonwood rows with cedar.

Walter Fick operates a 2700 acre ranch southeast of Inman. He has done considerable amounts of tree planting, grass seeding and blow out control work.

All of these ranchers are conscious of the importance of good grass for their livestock and at some time or another have completely deferred pastures for two or more years to improve both the quality and amount of grass. This year the judging committee reported that many of their pastures looked practically unused and that the amount of grass couldn't have been better.

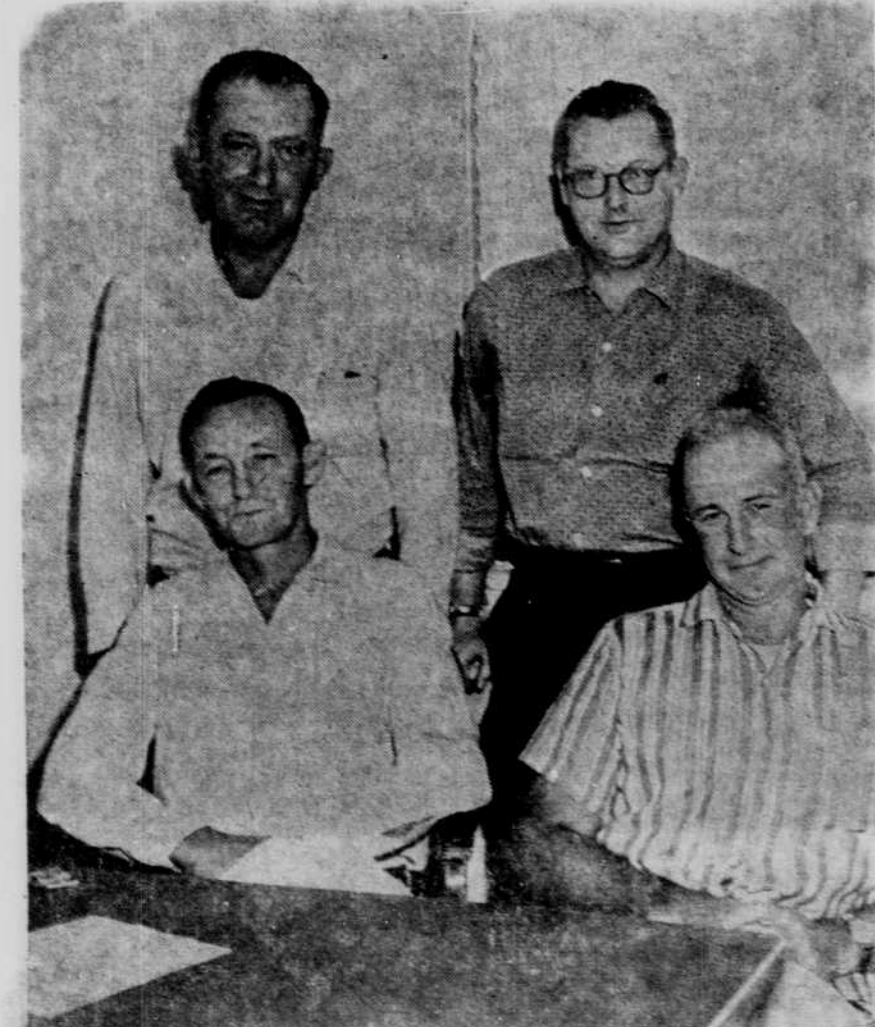

## Methodists To Meet at Atkinson

Bishop Kenneth Copeland, Methodist Bishop of the Nebraska Area, has called a series of information Convocations over the state to bring to all Methodists the details of the new Saint Paul School of Theology Methodist in Kansas City, Mo.

A traveling team composed of Bishop Copeland; Dr. Don W. Holter, President of the School; the Rev. Wayne Bartuff, assistant pastor of the Methodist church in Kearney, who graduated from this Seminary last June; Henry F. Meyer, financial consultant; and Dr. Richard Carlson, Chairman for Nebraska, will be the speakers.

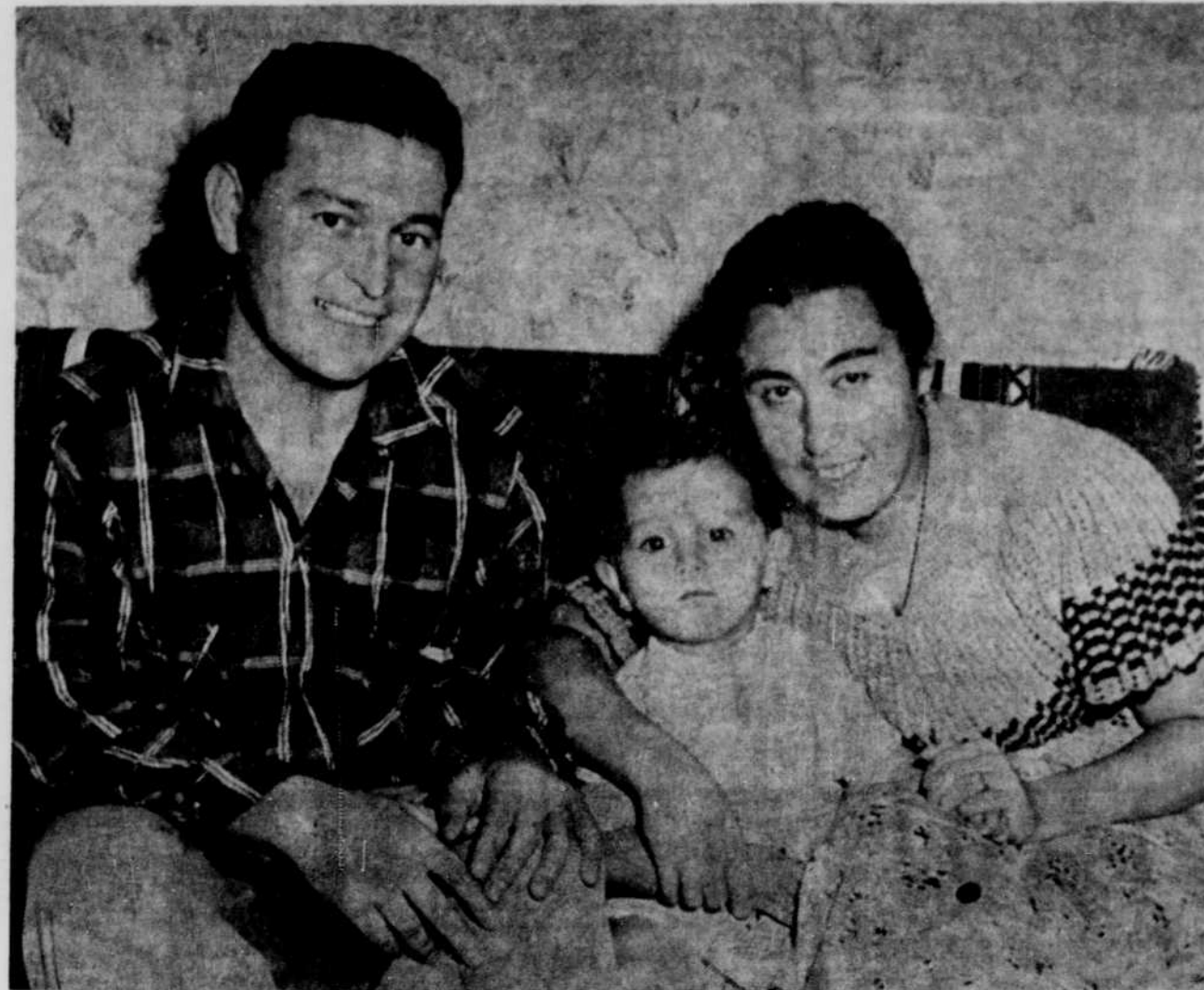
The new Seminary was founded three years ago. Bishop Copeland said, to help the Methodists recruit and train more ministers in an effort to meet the annual shortage of 2,000 Methodist ministers and missionaries.

The school has a faculty of 18 professors with an enrollment of 160 students. The first class of 17 was graduated last June.

The two conferences of Missouri and the Kansas Conference have already raised more than their share of \$2,600,000 towards a total goal of \$5,000,000. Bishop Copeland said the goal for the Nebraska Conference is \$700,000 to be raised by 1965.

These funds are needed to build the necessary buildings, purchase a campus, books and equipment. One million and a half will be set aside as endowment. The convocation for this area will be held at the First Methodist church of Atkinson, 7:30-9:00 p.m., September 11.

Bishop Copeland said all Methodists are urged to attend and secure all the information—No funds will be solicited at these meetings.

Sponsors of the Boyd County Sabin Oral Vaccine mass inoculation program are ready for the second phase to be held Sunday, Sept. 9. Again, two inoculation centers have been arranged. At the Spencer Community Hall, type III vaccine is offered from 1 - 3 p.m., at the Butte Legion Hall, type III vaccine is offered from 4 - 6 p.m. Sponsors will ask persons who receive the vaccine to contribute 25c per family member to defray expenses. Vaccine will be free to those who cannot afford to contribute.

There may be people who did not sign a coupon and take the first inoculation given on July 29. Those who did not send a coupon and who intend to take the next two inoculations are asked to obtain and send a coupon to Mrs. Thomas Bowers of Bristow, Neb.

Dr. Joseph David, Lynch, will again be at both inoculation centers with local nurses assisting. Parents with children who may have virus infections or have been ill and are not fully recovered on September 9 should consult a doctor before the children take the oral vaccine.

Type III must be given ahead of type II Sabin oral vaccine which will be given October 21.
