Eagles Win Holt County; Beat SMA in Finals

The undefeated Eagles of O'-Neill High overcame a threequarter deficit and came from behind to take top honors in the 25th annual Holt County Tournament. The big blue topped upset-minded St. Mary's in the finals Friday night as nearly 1400 basketball fans crowded into the SMA Auditorium. Tall boy Rich Hill scored 22 points for the Eagles in the 45-38 championship victory.

The hustling Cardinals took complete control of the game, leading 18-12 at the end of the first quarter and 26-23 at halftime, but coach Don Templemeyer's squad couldn't come through when the pressure was on. The highly favored Eagles held the Cards to two free throws in the final quarter while scoring 12 themselves, despite the fouling out of sophomore Ivan Hurley. The 6' 7" Hill committed his fourth foul early in the third quarter and didn't re-enter the Eagle's contest until midway through the final period.

Senior Owen Donohoe paced the Cardinals with 17 points, eight of these in the first quarter. Norm Mudloff poured in 10 the first half and wound up with 12 for row. the losers.

Forwards Ivan Hurley and Terry Kurtz scored 7 points each behind Hill's 22 point output. Senior Denny Drayton came off the bench and turned in a fine performance for the Eagles, replacing Hill and Hurley when the other boys found themselves in foul trouble. Drayton tapped in a fourth-quarter rebound that seemed to turn the tide for the big blue while teaming up with Hill and Hurley to control the boards during the final stanza.

Atkinson took consolation honors by stopping Stuart 68-49. The Balers got off to a quick lead and were never seriously threatened. Ken Claussen was high point man for the Balers with 19 and George Bigelow, who was followed.
