

EWING-A day's outing at the Ft. Randall reservoir ended in tragedy Sunday, June 10, for a Ewing family.

Mrs. Perry Saiser, wife of a retired rural mail carrier, was drowned when the boat in which she was riding capsized.

Her husband, 63, and their son, Raymond, 41, of Omaha, were other occupants. None was able to swim.

The three floundered in the water for 50 minutes before help arrived. Raymond held onto his mother but she died in the struggle.

The elder Mr. Saiser was wearing a life jacket. Although unable to swim, he managed to survive. He suffered from shock. High winds were partially lamed for the overturning of the craft.

Among those from this area who were in the vicinity of the tragedy were Mr. and Mrs. George Winkler of Emmet, Homer Barton of Orchard, Mr. Cavanaugh of Stuart, Mr. and Mrs. Melvin Kemper of Norfolk.

Several of the men helped effect the rescue of the Saiser men. The three Saisers had intended to leave Ewing this week to visit relatives in Washington state. Funeral services were conduct-


