SCHEDULES IN THEN SAYS ALLOTTING AGENT SCRIVEN.

SCRIVEN TALKS IN SIOUX FALLS

Provided the Unforeseen Does Not Arise Agent Says That Last Schedule Will Be Filed by September 15. Then Proclamation.

Sioux Falls, S. D., July 11.—Special Agent in Charge of the work of allotting lands to Sioux Indians in Gregory, Tripp and Meyer counties, while in Sioux Falls on business before the United States court, gave some interesting information in connection with the progress being made in the work of allotting lands to Indians in Tripp county.

The surplus lands of the Rosebud Indian reservation in Tripp county have been ceded to the United States and will be opened for settlement as soon as the work of allotting Indians in that county is completed.

Special Agent Scriven states that if nothing unforeseen arises himself and the men working under his direction will have completed the work of allotment in Tripp county, and he will have filed his schedule with the authorities at Washington, by September 15 next.

The excessive rainfall this spring has greatly interfered with the allotment work, and for days at a time it was absolutely impossible for the allotting crews to make their way about the country.

Agent Scriven was authorized to put on an additional crew in order to push the work of allotment, but owing to the excessive rainfall he has not yet been able to put the additional crew at work.

Alotting Agent Scriven is well aware of the impatience of the thousands of intending homesteaders to have the work completed so the land can be opened, and in the effort to push the work to completion at the earliest possible date he has personally worked day and night and Sundays in order not to lose any time.

Mr. Scriven has received a total of 809 applications from Indians who wish to take allotments in Meyer county. The only thing that can interfere with the opening in the fall of the surplus lands in Tripp county is whether or not some of these applicants will change their minds at the last moment and strive to secure allotments in Tripp instead of in Meyer county.

HAS PLATFORM PLANKS

Frontierman Won't Vote Till Some Party Takes His Three Planks.

Spokane, Wash., July 12.—B. E. Turnbull, pioneer and frontiersman of eastern Washington, and bonanza rancher in the Palouse wheat belt, south of Spokane, where he has lived more than thirty-five years, has prepared three planks which he desires incorporated in the platform of some political party, as follows:

"Plank 1. No man in the United States or any of the territories shall own or control more than 160 acres of land; and none unless he makes his home on it permanently.

"Plank 2. No person in the United States, either man or woman, shall manufacture or import into the United States any intoxicating beverages or liquors, under the penalty of death by electricity; and the government shall, upon a set day, buy at cost of manufacturing all the intoxicating liquor there is in the United States and pour it out on the ground or in the waters.

"Plank 3. No man or woman in the United States or any of the territories shall produce or import into the United States any tobacco, in any of its forms, or anything that contains tobacco, under the penalty of death by electricity. The government shall buy and burn all that exists."

Mr. Turnbull is a total abstainer from strong drink and flesh, fish and fowl and has lived for years on a diet of wheat cracked by his own hands. He is hale and hearty despite his seventy years. He has not voted since the close of the Civil war and declares he will not exercise his franchise for any man or party unless they are pledged to a platform in which the foregoing planks are included.
