SOUTH DAKOTA SHIPMENTS EARLIER THAN EVER BEFORE.

DALLAS GREAT SHIPPING POINT

Sunday Night Thirty Carloads of Range Cattle From U-Cross Ranch Were Shipped From Dallas—More Will Go Next Sunday.

Dallas, S. D., July 23.—From a staff correspondent: The shipment of range cattle to market began this year earlier than ever before in the history of the cattle country.

The first big shipment went out of Dallas last Sunday night—thirty carloads—from the U-Cross ranch. Next Sunday more will go. Mr. Humphreys, one of the owners of the ranch, looks for an unsteady market, and for this reason the shipments will be scattered through in comparatively small lots until December—to get an average market.

Dallas is one of the great cattle shipping points on the map today.

That Amount to be in Yankton Bank for Hill When Line is Built.

Fairfax, S. D., July 23.—From a staff correspondent: A man here from Yankton says Yankton people have put up \$76,000 in a bank to turn over to Fremont Hill as soon as the Gulf road is built.

Sioux Falls, S. D., July 23.—Special to staff: Arrivals from Pukwana, the thriving little town in the center of Brule county, which was practically destroyed by a tornado a little more than two weeks ago, report that it is quite rapidly recovering from the calamity, and that the new Pukwana which is being erected on the ruins of the old will be larger, more extensive and better than the old. A small army of men is engaged in the work of rebuilding the town. In all directions the sound of the hammer and the saw can be heard.

It has been decided that both the Methodist and the Catholic churches, which were reduced to kindling wood by the tornado, will be rebuilt at once. The Catholics were fortunate enough to have had tornado insurance to the amount of \$2,000, but the Methodist church was a complete loss except the lumber that can be saved from the wreckage. More than \$500 already has been contributed toward the fund for the building of a new Methodist church, and it is thought the building can be built and dedicated free from debt.

The valuable fixtures and furniture in the Catholic church were not covered by insurance, thus leaving the society with a marginal loss of about \$1,000. Nearly \$500 of this was raised in one evening among visitors who were in Pukwana. It is the intention of the trustees to raise the balance without soliciting contributions from any of those who were financial sufferers from the tornado. Men already have been set at work clearing away the wreckage preparatory to the commencement of the work of erecting the new edifice to take the place of the wrecked structure.

The task of rebuilding the town is a tremendous one, but the residents have taken hold with a will and are determined that the new Pukwana shall be a town of which all can be proud. ADD TO PHONE DISTRICT

NEBRASKA COMPANY EXTENDS DISTRICT NORTH AND WEST.

ASSISTANT MANAGER SENT HERE

Boundary Lines of Norfolk District Have Been Pushed from Atkinson to Valentine and from Creighton to Dallas.

Norfolk has been given additional recognition as a telephone center. An assistant manager has been assigned to the Norfolk district and the territory of which Norfolk is the headquarters extended west from Atkinson to Valentine and north from Creighton to Dallas.

The new assistant manager, J. R. Carter, has been manager of the Kearney district. Competition is apparently about to be eliminated from that vicinity and Mr. Carter has been transferred to Norfolk. In Kearney a consolidation of the two exchanges is tied up by court proceedings but otherwise has been virtually effected. The plant at Kearney will be operated under the sub-license plan.

Mr. Carter's headquarters will of course be in Norfolk. He will bring his family to this city as soon as a suitable home can be found.

Largest Territory in Nebraska. The action of the Nebraska Telephone company in adding to the jurisdiction of the Norfolk district the sub-license stations between Atkinson and Crookston and between Creighton and Dallas represents a big increase in the telephone territory tributary to Norfolk, the largest telephone district in Nebraska.

It is also said that since the extension there are more telephones under the supervision of the Norfolk district office than in any other district in the state.

Trips of inspection will be divided between Manager Sprecher and Assistant Manager Carter. It is also probable that one of the two will always be in Norfolk.
