the earth, he said, and grind it and its people to powder or ride full tilt into the sun, when the earth's living creatures would be scorched to death.

Tidal friction, by its gradually retarding force, might paralyze the earth's motion so that one side of the globe would be eternally baked by the sun and the other side forever frapped. This has already happened to Mercury and Venus.

By the loss of all water and air through depletion or absorption the earth might become a dry, desiccated mummy of a planet, wandering lifelessly through space. Mercury, again, is an example of this, and so is the moon. The most sure death of all. however, as depicted by Professor Lowell, is the decay and freezing of


