Political Affairs in Texas a "Muddle"

By MYRTLE MASON. Things queer and interesting are going on in Texas. It would be regrettable if Omaha women should miss the humor of the situation there, or fail to profit by the experience of women in politics elsewhere.

Mrs. Ferguson is running for the office of governor on the democratic ticket. She may, and the consensus of opinion here is, that she will be elected, in which case she will be the first woman governor in our country. It sounds simple enough, so stated, but "Ma" Ferguson has a husband. He was formerly governor of Texas and is a potent factor in his wife's candidacy. The Ku Klux Klan is an issue. Prohibition is involved. Women in public office, is another controversial point. In fact, there is a beautiful political "muddle" in Texas.

Eight years ago it was that Governor Ferguson opposed suffrage. According to Carrie Chapman Catt, his speech against a suffrage plank in his party's platform, was abridged, to the effect that God had determined the place in the world for women, and that place was the home, far removed from the limelight of politics. God had made women for obedience to men and men to take care of politics. The Bible opposed woman suffrage and he, Governor Ferguson, stood by God and the Bible.

Since then the governor has been practically impeached. In an editorial published in the Woman Citizen September 4, Mrs. Catt says in part: "Eight years have passed. Governor Ferguson was, meanwhile, nearly impeached on nine counts by the legislature, the charge being the misappropriation of funds; that is the process of impeachment was all complete except the final pronouncement of the trial and the pronouncement of

one knows. For a time it appeared Mrs. Ferguson was as good as elected, the republican candidate having, it was said, withdrawn in her favor, and a democratic nomination being normally equivalent to election in Texas. But now, we understand, there is a movement on to declare Mrs. Ferguson's candidacy unconstitutional. Yesterday morning (Saturday, September 13.) The Omaha Bee carried the story from New York that George C. Butte of Austin, Tex., just landed from Europe, made a dash for the first train to Texas, having just been informed that he had been nominated to run as the republican candidate against "Ma" Ferguson. Dr. Butte is dean of the law school at the University of Texas. He claims to know none of the political leaders in his state." Dr. Butte attended the American Bar association meeting abroad and placed his son, George, in Oxford college.

"Ma" Ferguson admits a deference to her husband in certain matters and makes it clear she would let him have some power of dictation in the event of her election. She is reported to have said in an interview: "All I have to say about prohibition is that it is settled. It's the law, so why discuss it? However, I will tell you that I will veto any liquor bills that come before me as governor. I know that I will be personally responsible for my official acts, and I shall accept that responsibility." In reference to the administration of fiscal affairs of the government, reduction of taxes, management of the penitentiary and other business of the state, I feel sure that Mrs. Ferguson's judgment is better than mine. But with reference to matters affecting education and social affairs, and particularly the interests of the home, the women and children, the efficient enforcement of the laws and maintenance of peace and order, I feel that my judgment is as good and in many respects better than that of my husband, and with reference to such matters I shall be guided by my own judgment in the light of such knowledge and conditions as I shall be able to acquire."
