Judge A. B. Duncan, St. Joseph, past grand worthy president of the Eagles, will be the guest of Council Bluffs aerie No. 104, Thursday.

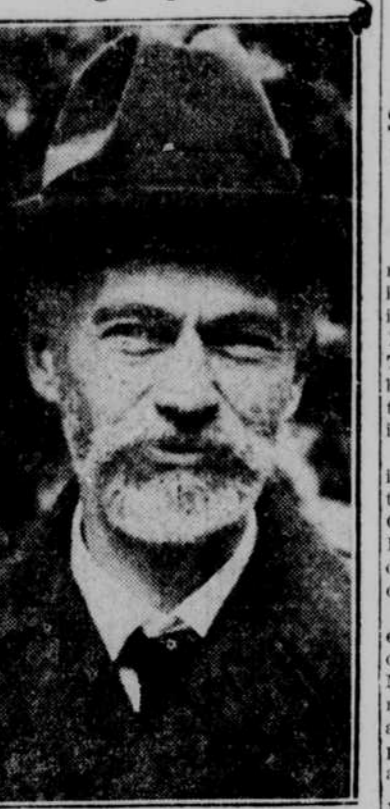
