

EGYPT TO GET STERN MISSIVE London, Nov. 20.—Premier Stanley Baldwin and Lieutenant General Amery conferred today regarding the Egyptian situation and the attempted assassination of Sir Lee Stack. They decided, it is understood, to dispatch a stern note to Egypt, charging the Egyptian government with raising the Sudan question and in this manner incurring direct responsibility for the attack on Stack.

REDS WON'T PAY DEBT TO FRANCE Stockholm, Nov. 20.—Russia has resolved not to pay its debt to France, but is willing to transfer to France all the French iron and coal concessions which have become nationalized under the Soviet regime, as well as make important new concessions, according to advices reaching here from Russia.
