Here Is the List of Some of the Things Omaha Post No. 1 Did During 1924---

Maintained 5-bed ward in local hospital which has provided hospitalization for several hundred service men.

The Post's employment bureau secured approximately 1,500 jobs during the past year for service men.

Provided meals and lodging for 500 men.

Gave assistance to approximately 5,000 men in applying for the government Adjusted Compensation certificates.

Conducted twenty funerals of service men.

Collaborated with American War Mothers in placing name plates on trees planted in memory of deceased service men.

Co-operated with existing agencies in the promotion of Americanization work.

Sponsered a Boy Scout troop.

Developed Omaha Post Drum and Bugle Corps, the finest in America.

Provided Thanksgiving and Christmas baskets for families of fifty service men.

Provided a Thanksgiving and a Christmas dinner for thirty transient service men. Assisted with over 2,000 claims of veterans for disability compensation, vocational training and hospitalization.

Assisted with over 2,000 claims of veterans for various kinds of service claims—state bonuses, lost discharges, allotn rits, back pay, etc.

Assisted with food, fuel, clothing, rent, medical care, etc., in more than 1,200 cases.

Provided service men and their families, and also a large number of transient veterans, with articles of clothing turned in by members of the Post.

Maintains a trained liaison officer who represents veterans before the Veterans' Bureau. He assists in preparing their claims, and in case of dissatisfaction with the rating or diagnosis given by the Bureau, he argues the claim before the Rating Board.

Provides the service of a lawyer in cases before the Veterans' Bureau which hinge on a legal question.

Has established a Medical Clinic, composed of leading specialists of the city, who examine service men who are not satisfied with the diagnosis or rating given them by the medical staff of the Veterans' Bureau.
