SPILLMAN OPENS 'GAS' QUERRY HERE

Elrod Charges Plot to Put 15-Cent Station Out of Business.

Attorney General O. S. Spillman and his Omaha assistant, Attorney T. J. McGuire, are continuing their investigation of the local gasoline situation.

Some of the phases of the case were suggested as follows, Friday morning with these state officials: Having the various companies, operating many filling stations here, conspired in bringing the price down to 12 cents.

Governor Bryan is three jumps behind on the gasoline question, just as he is on other matters. When he hears that I am investigating something, he directs me to investigate that very thing. If it works out all right he wants the credit, and if it does not prove successful, he blames my department."

Among the callers at the attorney general's Omaha office Friday morning was Attorney John P. Breen, representing E. S. Elrod and E. E. Howell, joint proprietors of a 15-cent gasoline station near Sixteenth and Nicholas streets.

Breen cited the law which prohibits any person or corporation selling any commodity below a fair profit if such sale is for the purpose of driving out competition. He is across the 15-cent station which is across the street from the filling station of his clients.

The contention is that gasoline now costs 12 1/2 cents per gallon, f. o. b. Omaha. And Breen inquires how it can be sold at 15 cents at a profit.
