THEY FINALLY GET TOGETHER ON THE TARIFF BILL.

UNUSUALLY LARGE ATTENDANCE

Members State Their Objections to the Bill-The Sugar -chedule the Principal Bone of Contention - Nothing Definite Decided on-The Republican Program Outlined-Capital News.

WASHINGTON, Jan. 8.-Unusual precautions were taken to preserve the secrecy of the proceedings of the caucus of the Democratic members of the house on the tariff bill last night. Reporters were shut out.

It was 8:05 when Chairman Holman rapped the caucus to order and the reading clerk began to call the roll. One hundred and forty-seven members answered to their names, an unusually large attendance and greater than had been anticipated on this occasion.

After considerable discussion the

following was unanimously adopted:
Resolved, That it is the sense of this
caucus that it is the duty of every
Democratic member of the house to vote for the pending resolution provid-ing for the consideration of the tariff

ing for the consideration of the tariff bill in order that the house may have an opportunity to redeem the pledges of the party respecting tariff reform. Resolved, further, That it is the duty of every Democratic member of the house to attend its daily sessions, and we hereby express the opinion that those members who are absent owe it to the party and to those of us who are here, to immediately return, in that pressing public business may be attended to.

Representative Harter of Ohio,

Representative Harter of Ohio, brought up the matter of the sugar schedule, and offered the following as s substitute for the provisions of the bill as reported by the committee on

that subject: Section 180. That the bounties authorized to be paid to producers of sugar by section 281 of the McKinley bill shall cease and terminate upon the passage of the bill.

Mr. Robertson of Louisiana pro-

posed a duty of three-fourths of a cent per pound on all sugars below sixteen dutch standard and above that grade a duty of 1% cents per pound.

Mr. Price of Louisiana was on his

feet to propose that the provisions of the Mills bill relating to sugar should be substituted for those of the Wilson bill, when at 11 o'clock it was moved that the caucus adjourn, which motion was carried.

A TRACEDY IN ST. JOSEPH.

Jennie Punshon Kills Herself While Riding in a Cab.

Sr. Joseph, Mo., Jan. 8. - Last evening at 8 o'clock, Thomas Punshon, a freman on the Santa Fe road, and his wife were riding in the cab of Thomas Donahoe. A shot was heard and Punshon stated to the cabman that his wife had suicided. The party was at once driven to the residence of George Punshon, brother to Thomas, where the woman was taken from the cab a corpse.

Punshon's story is that he and his wife had separated and had agreed to make up. To-day he called at the residence of his wife's mother, who refused to submit to a reconciliation. He states that his wife asked him to get her either poison or a pistol, as she was tired of life. He persuaded her, however, to again live with him, and she agreed that if he would call with a cab in the evening, she would get away from her mother. He did this, and they were being driven to the residence of his brother when she suddenly put a pistol to her right temple and pullad the trigger.

CORRESPONDENCE FROM WILLIA

Some Important Documents Which Have Not Hitherto Been Published. Washington, Jan. 8.—There was issued from the government printing the president on Hawaii and the acthe senate has asked for by resolu-tion. In the printed copies are some reports from Minister Willis, which have not heretofore been published and which are of special interest at this time.

Under date of November 11, from Honolulu, Minister Willis announces to Secretary Gresham the presentation of his letter accrediting him as Mr. Blount's successor. The document then continues: 'On the afternoon of the 6th the British minister, Major Wodehouse, called my attention to the following paragraph in the Hawaiian Star of the same date: 'It would serve the ex-queen well to pray to her gods that the peril of restoration will never come to her,' which he interpre-ted to be a threat of assassination, and inquired whether our government was ready and willing to extend to her its protection. I replied without reference to her royal claims, she stood in such relations to the United States that she was entitled to and would receive the amplest protection at our hands. As a matter of fact, I had already ascertained that, at present, she did not desire our protection.

After next Monday, however, and earlier if necessary, I shall insist on her coming to the legation.

"Neither side has the vaguest idea as yet of the attitude of our government and consequently no outbreak has occurred, although every night is filled with rumors. The United States ships Philadelphia and Adams are connected with Honolulu by telephone, but in the event of riot Admiral Irwin, now in command, has made arrangements for rocket signaling. On Monday I will, by request, meet a com-mittee of the American league, which, one who claimed to be a member, in-formed me was 600 strong armed with Winchester rifles and would never permit the restoration of the queen. He further intimated the league had some fear the provisional government Thirty Persons Killed in One Town and "would make concessions and surrender their rights, and if so they would never throw it," etc.

There is undoubtedly in this government, as in all governments, a class of reckless, lawless men who, under the impression they have the moral support of some of the better class of citizens, may at any moment bring about a serious condition of affairs. Fortunately the leaders of the provisional government are acknowledged by all sides to be of the highest integrity and public spirit, which, combined with the large material interests they represent will, it is hoped, cause them to stand firmly and successfully for peace and good govern-

The Japanese consul general has just called to say his people, who number nearly one-third of the male population, are very apprehensive of inmediate disturbances. He desired to know whether I would advise him to send for a man of war. I declined to give him any advice. He then inquired whether his people could expect any protection from the United States troops. I told him if it was his request, and that if his people were non-participants in the trouble that he could probably rely on the protection of our government. American interersts here are so extensive and all interests are so close that it is impossible to touch one without involving all. With sentiments of high regard lam, etc.

The Conflict Said to Have Occurred Well Within the English Lines in Africa -Intense Excitement in London -France Offers to Make Suitable Reparation-Rioters Killed.

LONDON, Jan. 8 .- Intense excitement has been caused here by reports of a battle between French and British troops on the frontiers of Sierra Leone, on the northwest coast of Africa.

Particulars of the engagement received to-day are that a British force numbering about 500 native troops, sent against the sofas, was encamped office yesterday the special message of near Warina, in the sphere of British influence, when, shortly before daycompanying correspondence which light, December 23, during a bright moonlight, they were attacked without warning by thirty Senegalese sharpshooters, supported by 200 native French auxiliaries under Lieutenant Moritz of the French regular army. The French opened fire upon the British, who replied. After the fighting had continued for some time the French retired and Lieutenant Moritz, who had been wounded, was captured by the British and brought

Upon being questioned as to his reason for opening fire upon the Brit-ish troops, Lleutenant Moritz declared that he mistook the British force for a force of Sofas under European officers and Arab leaders. It is now said that this statement of the French officer makes it perfectly clear that a mis-take was made by the French and that no responsibility attaches to British officers.

In spite of assistance promptly ren-dered to him he died of his wounds. Ten of the Senegalese sharpshooters were killed and of the frontier police which accompanied the expedition in addition to Inspector General Lendy two were killed and three seriously wounded. The British force, it i added, remains at Warins.

The colonial office announces that the affair will be made the subject of a stringent inquiry so soon as the full details of the affair are received from the governor of Sierra Leone.

France May Offer Reparation.

PARIS, Jan. 8 .- At a cabinet council, called this morning in order to consider the encounter between French and British troops, on the borders of Sierra Leone, it was decided that if the English version of the affair turns out to be correct the French government will not contest the necessity of making the reparation provided by international law.

DEADLY RIOTS IN SICILY.

PALERMO, Cicily, Jan. 8 .- At Marino, a town of 9,000 inhabitants, a body of rioters demanding the abolition of the octroi duties made an attack on the town hall. Troops resisted and thirty of the rioters were killed and fifty wounded.

A dispatch from Caltinezza says that there was a demonstration there last evening under the auspices of the Fasci del Lavoratori, which wound up a conflict between the troops and the peasants. One of the soldiers was wounded by a peasant and the troops fired a volley into the crowd of rioters and killed ten and wounded several others.

MRS. COCKRELL DEAD.

The Wife of the Missouri Senator Suc cumbs Under Sad Circumstances.

WASHINGTON, Jan. 8.-Mrs. M. F. Cockrell, wife of Senator Cockrell of Missouri, died at 1:50 o'clock this afternoon at the family residence in this city. Her death was hourly expected as the attack of pneumonia from which she died developed an acute form nearly two days ago. A cold caught at the society debut of her daughter was the cause.

Mrs. Cockrell was Miss Anna Ewing, eldest daughter of the late Judge Ephraim B. Ewing, of the supreme She was married court of Missouri. to Senator Cockrell at St. Louis in July, 1873, being his third wife. The first Mrs. Cockrell died in December, 1859, and left three sons. The second, who was Anna E. Mann, daughter of James B. Mann of Kentucky, died of bench. On the governor's accept-

SENATOR TELLER TALKS. Says the Outlook for Colorado is Very Bad-Denounces Gov. Waite.

DENVER, Col., Jan ! - Senator Teller returned yesterday from a brief visit to Mexico. In an interview last night he said the outlook for Colorado was very gloomy and in his opinion would not change so long as the present administration should be in power. He will be satisfied, however, that the condition of the poor and the finances were much better in Colerado than in any of the Eastern states

The senator denounced the extra session scheme of Governor Waite as one of the worst things that could have happened to Colorado. While in Mexico he talked with several officials regarding Gov-ernor Waite's proposition to circulate Mexican dollars in Colorado as legal tender. The number of offices of the three presidential classes is 3,424. There are 151 in the first class, where their receipts are more than \$40,000; 674 in the second class, where receipts range from \$5,000 to \$40,000, and 2,599 in the third class, where receipts range from \$1,900 to \$8,000. There are also 65,382 fourth class offices.


